May kindly see the letter dated 19.11.2003, placed below at fleg'A, received from Sri Raksh Kumar Nain, Addl. Civil Judge (Junior Division), Dcoband, Saharanpur regarding grant of permission to submit his thesis in the Chaudhary Charan Singh University, Meerut.

In his letter, Sri Nain has stated that since before joining of the present Judicial service of U.P., he was doing research work since 07.06.1996 under the supervision of Dr. S.P.Bansal in Chaudhary Charan Singh University, Meerut, but due to some unavoidable circumstances, he could not submit the thesis work in time. Now, he has been granted time upto 31.12.2003 by the Vice Chancellor of the University to submit the thesis for LL.D. Degree. Sri Nain has, therefore, requested the Court to grant him permission to submit the thesis for LL.D. Degree in the University.

In this connection it is submitted that as per record of the Court, Sri Nain has joined the U.P.Nyayik Sewa in the Year 1999 vide Court's notification dated 28.7.1999. He had not informed earlier about his thesis work after joining the Judicial service , but as he has completed the thesis work now and requested to grant him permission to submit the thesis for LL.D. Degree in the University, his case may be considered sympathically for grant of permission for the same. Such types of permissions are granted in accordance with Government order No. 24/10/66(i) Appointment (B) dated 21.8.1967 (Copy at Flag 'B').

It is further submitted that Sri Nain , who has been posted now as Civil Judge (J.D.), Sadar, Faizabad, vide his letter dated 10.09.2004 (flagged'A-1') has informed the Court that he had completed his thesis work since before joining of Judicial service and now Chaudhary Charan Singh University, Meerut has granted him LL.D.Degree. He has also furnished a copy of Provisional degree of LL.D.. which is at flag'C'. In the circumstances, the matter requires regularization due to the fact that the officer has completed the thesis work since before joining of the Judicial service and now LL.D. degree has already been granted to him by the University.

A Under the circumstances, if approved by Hon'ble the Chief Justice, Sri Rakesh Kumar Nain, Civil Judge (Jr. Div.), Sadar, Faizabad may be accorded ex-post facto permission to submit his thesis work in Chaudhary Charan Singh University, Meerut for the purpose of taking LL.D. Degree, as requested ?
