May kindly see the letter dated 1.7.2015 (flagged 'A') of Dr. Rakesh Kumar Nain, Additional District and Sessions Judge, Kaushambi by which he has submitted his immovable property statements for the financial years 2012-13 and 2013-14.

Earlier the officer has submitted his only consolidated movable property statements for the financial years 2012-13 and 2013-14 vide his letter dated 1.5.2015(flag 'B') and he has not submitted his immovable property statements for the aforesaid periods, hence a Court's letter dated 4.6.15(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted his immovable property statements for the financial years 2012-13 and 2013-14 vide his letter dated 1.7.2015(flag 'A').

In this connection, it is submitted that as per consolidated statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

In the financial year 2012-13 and 2013-14, Gross Income from salary and other Sources of Dr. Nain is Rs.32,06,007/- and from this amount, Rs.2,09,249/- is deducted against GPF, Rs.9,600/- against GIS, Rs.2,99,600/- against Income Tax, Rs.600/- against others expenses, Rs.1,11,252/- towards car loan, Rs.57,850/- against LIC, Rs.4,00,000/- against STDR. The balance of his Saving Bank Account(s) enhanced for Rs.12,60,609/- in two financial years. As such, total deductions /Savings /investment is Rs.23,48,760/-. Thus a sum of Rs.8,57,247/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2012-13 and 2013-14.

It is pertinent to mention here that the Annual Income of the wife of the officer Dr. Rajni Nain is Rs.3,14,862/- from consultancy and interest in the financial years 2012-13 and 2013-14.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 1.5.2015 (flagged 'B') which was due to be submitted in third financial years 2014-15 i.e. on or before 31.3.15. As such there is ^{some} delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted Dr. Nain had already submitted his property statement upto financial year 2011-12 which had already been seen by Hon'ble Mr. Justice Krishna Murari the then Administrative Judge, Moradabad Judgeship which is at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the consolidated statements of movable and
