May kindly see the letter dated 30.10.2018 (at flag 'A') by which Dr. Rakesh Kumar Nain, Additional District and sessions judge, Deoband, Saharanpur has submitted his consolidated statement of movable and immovable property for the financial years 2014-15 & 2015-16, 2016-17 & 2017-18.

In this connection, it is submitted that as per consolidated statement of movable and immovable property for the financial years 2014-15 & 2015-16, 2016-17 & 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(i) In the consolidated property statements financial years 2014-15 & 2015-16, Sri Nain total income from salary and other Sources is Rs.34,06,489/- (Rs.28,62,475/- from Salary, Rs.531993/- from Bank interest, Rs.8421/- from T.A.Bill, Rs.600/- from Mandeya from Lok Adalat and Rs.3000/- from Deputation allowance.) from this amount he has paid Rs.2,49408/- against GPF, Rs.9600/- against GIS, Rs.585740/- against Income Tax, Rs.1,11,252/- towards car loan, Rs.57,350/- against LIC. As such, total deductions /Savings/ investment are Rs.10,13,350/-. The balance of his Saving Bank Account(s) decreased for Rs.4,93,557/- in this year. Thus a sum of Rs.28,86,696/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2014-15 & 2015-16.

(ii) In the consolidated property statements financial years 2016-17 & 2017-18, Sri Nain total income from salary and other Sources is Rs.39,10,608/- (Rs.32,27,347/- from Salary, Rs.2,97,373/- from Bank interest, Rs.2,22,871/- from T.A./T.R., Rs.8421/- from T.A.Bill, Rs.600/- from Mandeya from Lok Adalat and Rs.54,000/- from Deputation allowance.) from this amount he has paid Rs.2,77,898/- against GPF, Rs.9600/- against GIS, Rs.6,80,000/- against Income Tax, Rs.57,350/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.2,73,833/- in this year. As such, total deductions /Savings/ investment are Rs.12,98,681/-. Thus a sum of Rs.26,11,927/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2016-17 & 2017-18.

The movable and immovable property statement for the financial years 2014-15 & 2015-16, 2016-17 & 2017-18 has been submitted by the officer vide his letter dated 30.10.2018 (flag 'A'). Movable and immovable property statement for the financial years 2014-15 & 2015-16 was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17 and movable and immovable property statement for the financial years 2016-17 & 2017-18 was due to be submitted in third financial year 2018-19 i.e. on or before 31.3.19. As such there is delay in submitting the movable and immovable property statement for the financial years 2014-15 & 2015-16 from the part of officer for which officer has stated that due to Cancer to his daughter he was busy in her treatment

and not submit the same in due time.

In this connection, it is submitted that Sri Nain had already submitted his property statement upto financial year 2013-14 which was seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kaushambi Judgeship at flag 'Z' and the statement is at flag 'M'.

May, if approved, the consolidated statements of movable and immovable property for the financial years 2014-15 & 2015-16, 2016-17 & 2017-18 of Dr. Rakesh Kumar Nain, Additional District and sessions judge, Deoband, Saharanpur may kindly be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
