Sir,

With reference to your letter no. 321/I Kaushambi, dated 28-03-2016, on the aforesaid subject, I am directed to inform you that in pursuance of G.O. and guidelines approved by Hon'ble the Chief Justice three advance increments is being granted to only those judicial officer of U.P. Nyayik Sewa & U.P.H.J.S. (Direct Recruits) who have been selected having degree of LL.M. from a recognized University and have mentioned this fact in the application form submitted at the time of direct recruitment to U.P.P.S.C. or the High Court, as the case may be.

On the basis of aforesaid guidelines, Dr. Rakesh Kumar Nain was found eligible for granting of three advance increments.
