May kindly see below placed letter dated 28-03-2016 of District Judge, Kaushambi regarding verification of Degree of LL.M. of Dr. Rakesh Kumar Nain, the then Addl. District & Sessions Judge, Kaushambi now posted as Chairman, Waqf Tribunal, Rampur.

In above mentioned letter, District Judge, Kaushambi has informed that in compliance of Court's order dated 09-12-15 related to grant of three advance increments to those Judicial Officer who have been selected having degree of LL.M. and have mentioned this fact in the application form of U.P. Nyayik Sewa or U.P.H.J.S. subject to verification of their degree from concerned University. A correspondence was made to ~~CB~~ University, Meerut regarding verification of Degree of LL.M. of Dr. Rakesh Kumar Nain. As per university records it was found genuine (at flag A). He has requested to intimate whether the officer has mentioned details regarding qualification of LL.M. in his application form of U.P. Nyayik Sewa or not so that further necessary action may be taken in the matter.

In this context, it is relevant to mention here that in pursuance of Government orders and guidelines approved by Hon'ble the Chief Justice on 07-08-2015, the financial benefit of three advance increments is being granted to only those Judicial Officers of U.P. Nyayik Sewa & U.P.H.J.S(Direct Recruits) who have been selected having Degree of LL.M from a recognized University and have mentioned this fact in their application form submitted at the time of direct recruitment to U.P.P.S.C or the High Court, as the case may be. On perusal of service record it has been observed that officer had fulfilled the required terms and conditions regarding grant of three advance increments. On the basis of aforesaid guidelines vide resolution dated 05-11-15, Hon'ble Committee has recommended for granting the three advance increments and with the approval dated 16-11-15 of Hon'ble the Chief Justice the financial benefit of three advance increments was granted to Dr. Rakesh Kumar Nain, the then Addl. District & Sessions Judge, Kaushambi and presently posted as Chairman, Waqf Tribunal, Rampur by this Court and in compliance of which a Court's letter No. 16799/IV f-82(loose)/Admin.(A)/ Allahabad dated 09-12-2015 was issued to District Judge, Kaushambi, for allowing three advance increments with dearness allowance to him w.e.f initial date of his joining in judicial service or w.e.f. 21-03-2002 when the relevant recommendations of the Hon'ble Shetty Commission were accepted by the Govt. of U.P., which ever is later on.

In view of above facts & Circumstances, may if deemed fit & proper, the file be placed before Ld. Sr. Registrar (Judicial)(Budget), for kind perusal and order to the effect that District Judge, Kaushambi may be informed accordingly and requested to do the needful as per Court's letter dated 09-12-15 at his end?
