May kindly see the letters dated 28.4.14 and 19.6.14 (at flag 'A' and A-1) of Sri Chhatradhari Singh Yadav, Additional District Judge, Pratapgarh by which he has submitted his Property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2010-11, Sri Yadav's Gross income from salary and other sources is Rs.14,34,180/-, from this amount, he has paid Rs.4,42,804/- against GPF, Rs.3580/- against GIS, Rs.2,44,204/- against Income Tax, Rs.11,690/- against LIC, Rs.70,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.1,43,181/-. As such, total deductions /Savings/investment is Rs.9,15,559/- this year. Thus a sum of Rs.5,18,621/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2010-11.

(2) In the financial year 2011-12, Sri Yadav's Gross income from salary and other sources is Rs.12,23,696/-, from this amount, he has paid Rs.85,897/- against GPF, Rs.4300/- against GIS, Rs.1,94,782/- against Income Tax, Rs.11,690/- against LIC, Rs.1,00,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.3,50,468/-. As such, total deductions /Savings/investment is Rs.7,47,637/- this year. Thus a sum of Rs.4,76,059/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2011-12.

(3) In the financial year 2012-13, Sri Yadav's Gross income from salary and other sources is Rs.11,81,493/-, from this amount, he has paid Rs.94,091/- against GPF, Rs.4800/- against GIS, Rs.1,03,935/- against Income Tax, Rs.1,00,000/- against PPF, Rs.8,00,000/- F.D, Rs.11,690/- against LIC. As such, total deductions /Savings/investment is Rs.11,14,516/- this year. The balance of his Saving Bank Account(s) decreased for Rs.2,00,000/-. Thus a sum of Rs.2,66,977/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2012-13.

(4) In the financial year 2013-14, Sri Yadav's Gross income from salary and other sources is Rs.11,37,229/-, from this amount, he has paid Rs.94,361/- against GPF, Rs.4800/- against GIS, Rs.1,32,069/- against Income Tax, Rs.1,00,000/- against PPF, Rs.8,00,000/- F.D, Rs.11,690/- against LIC. As such, total deductions /Savings/investment is Rs.11,31,230/- this year. The balance of his Saving Bank Account(s) decreased for Rs.2,55,833/-. Thus a sum of Rs.2,61,832/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 28.4.14 (flag 'A'). The property statement for the financial years 2010-11 and

2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13 and The property statement for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the property statement for the financial years 2010-11 and 2011-12 from the part of the officer.

In this connection, it is submitted that Sri Yadav has already submitted his property statement upto 2009-10 which was seen by Hon'ble Mr. Justice Abhinava Upadhyaya, Administrative Judge, Hamirpur on dated 9.7.10 at flag 'Z' and the said statement is at flag 'M'.

May kindly see the letter, placed below at flag 'A', received from Sri Chhatradhari Singh Yadav, Principal Judge, Family Court, Pratapgarh regarding issuance of 'No Objection Certificate' for obtaining Passport.

In his letter, Sri Yadav has stated that he wants to go to the religious tour of 'Kailash Mansarover', for which Passport is needed and to apply for passport 'No Objection/ Identity Certificate' from the Hon'ble Court is required. He has also enclosed three passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. Smt. Shushila Yadav (Wife) & Mr. Dhruvesh Singh Yadav (Son) are dependent family members of the officer. He has, therefore, requested to for issuance of 'No Objection Certificate' for obtaining passport.
