May kindly see the representation dated 10-12-2001 (Flagged 'A') of Sri Chhatra Dhari Singh Yadav, Civil Judge (Jr Division) Sultanpur duly forwarded by the Distt. Judge, Sultanpur regarding sanction of personal pay under Voluntary Family Planning Programme - in terms of G.O. no. Pa. Ka. 4601/16-11-79-9/155/79, dated 23-2-1980.

According to papers received from Sri Chhatra Dhari Singh Yadav along with his afore said representation and the papers on record of this Court, the details of claim are as under:-

- ① His Date of Birth is 1-12-1959
- ② His present age is 42 Years
- ③ He joined service on 27-9-99 (vide report of Section Officer (services) at Flag 'B')
- ④ He has only one child (vide declaration at flag 'B')
- ⑤ The age of his child is 12 years. His date of birth is 24-11-1989 (vide Schooling Certificate issued by the Principal, Jiny JOTS Public School, Sultanpur at flag 'B')
- ⑥ His wife is alive and she is not a govt. servant (vide declaration at flag 'E')

Neither any disciplinary proceedings have been started against him nor he has been suspended. He has also not been punished by stoppage of increment (vide report of Section Officer Confidential 'A'). Moreover, there is no vigilance enquiry is pending against him as per report obtained from the P.S. to the Special Vigilance Officer (Both the reports are placed at flag 'F').

In terms of G.O. no. Pa.Ka. 1683/16-11-80-9/155/79, dated May 26, 1980 and G.O. no. 2667/16-11-80-9/155/79, dated June 11, 1980, required declarations have been furnished by him and the same is at flag 'E'.

In the light of relevant G.Os. Sri Chhatra Dhari Singh Yadav, Civil Judge (Jr Division), Sultanpur fulfills all the declarations as laid down in the G.Os. for sanction of personal pay equal to one increment under Voluntary Family Planning Programme as his son completed his completed 10 years age on 24-11-1999 being the date of birth 24-11-1989, whereas Sri Singh Yadav completed his 40 years age on 1-12-99 being his date of birth 1-12-1959. As such he became entitled the afore-said benefit w.e.f. from ~~1-12-99~~ 1-12-99.
