May kindly see the office note dated 16.8.10 at Flag 'X', regarding submission of movable and immovable property acquired/ held by Sri Awadh Behari Singh, Addl. Chief Judl. Magistrate, Gautam Budh Nagar for the Calendar year 1999,2000,2001,2002, 2003 and for the financial year 204-05, 2005-06, 2006-07 and 2007-08 which was submitted before Hon'ble Mr. Justice Intiaz Murtaza, Administrative Judge, Gautam Budh Nagar for kind perusal and orders on the perusal of the statement. His Lordship has been pleased to order as under:-

"Perused the details submitted by the officer. The Office has not appended any comment about authenticity of details. The office shall scrutinize the statement and submit report about its being consistent.

However, the delay in submission of statement of movable and immovable property is condoned. However the officer be asked not to commit default in submission of statement henceforth."

In response of the aforesaid Court's order, office has made calculation of the aforesaid property statement and found that After deductions, savings and investment made by the officer during the Calendar year 1999,2000, 2001, 2002, 2003 and financial year 2004-05, 2005-06, 2006-07 and 2007-08 the rest amount comes to Rs.22,617.00, Rs.1,43,374.00, Rs.37,129.00 ,Rs.36,842.00, Rs.205635.00, Rs.88,393.00,Rs.26,274.00, Rs.1,00,000.00 and Rs.2,56,000.00(approx.) respectively.

It is further submitted that the authenticity of the details submitted by the officer is only supposed to be verified by the District Judge concerned and this office is not in a position to authenticate the same. However, there appears to be meager sum available with the officer in some years for household expenses as mentioned above, after officer's Savings, investments and repayment of loan etc.

If approved, the file may be laid before Hon'ble Mr. Justice Intiyaz Murtaza, Administrative Judge, Gautam Budh Nagar Judgeship for his Lordship's kind perusal and orders ?
