May kindly see the letter dated 3.1.13 (flagged 'A-1') by which Sri Avadh Bihari Singh, the then Additional Chief Judicial Magistrate, Gautam Budh Nagar Presently Chief Judicial Magistrate, Bahraich regarding delay in submission of property statement for the financial years 2008-09 and 2009-10.

Earlier Sri Singh has submitted his property statement for the financial years 2008-09, 2009-10 , 2010-11 and 2011-12 vide his letter dated 8.10.12(flagged 'A') which was put up before Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Gautam Budh Nagar. But His Lordship's has been pleased to order(Verbal) that the officer be asked to give specific reason for delay in submission of property statement for the financial years 2008-09 and 2009-10. Thereafter a Court's letter dated 18.12.12 (flagged 'B') was sent to the Officer in this regard.

In reply, vide his letter dated 3.1.13(flagged A-1), the Officer has submitted the reason for delay that earlier he had submitted his property statements for earlier years, on 12.7.2010 and he has calculated the the interval of two years thereafter from the date of 12.7.2010. However, for his mistake, he has regretted for delay submission of aforesaid statement and also stated that in future he will submit his property statement in due time.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto Financial year 2007-08 which was seen by Hon'ble Mr. Justice Imtiyaz Murtaza , the then Administrative Judge, Gautam Budh Nagar Judgeship on 16.9.10 at flag 'Z'.

May, if approved, the statements of movable and immovable property for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 of Sri Avadh Bihari Singh, Presently Chief Judicial Magistrate, Bahraich be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Bahraich Judgeship for kind perusal and orders ?
