May kindly see the letters dated 3.7.14 (at flag 'A') of Sri Awadh Bihari Singh, Additional District and Sessions Judge, Bahraich by which he has submitted his Property statement for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2012-13, Sri Singh's Gross income from salary is Rs.14,28,581/-, from this amount, he has paid Rs.95,390/- against GPF, Rs.4800/- against GIS, Rs.51,902/- against LIC, Rs.1,11,307/- against Income Tax, Rs.30,000/- against PPF, Rs.3,20,124 against Housing loan. The balance of his Saving Bank Account(s) enhanced for Rs.90,226/- this year. As such, total deductions /Savings/investment is Rs.7,03,749/-. Thus a sum of Rs.7,24,832/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.

(2) In the financial year 2013-14, Sri Singh's Gross income from salary is Rs.12,31,563/-, from this amount, he has paid Rs.78,805/- against GPF, Rs.4800/- against GIS, Rs.51,902/- against LIC, Rs.98,061/- against Income Tax, Rs.30,000/- against PPF, Rs.3,20,124 against Housing loan. As such, total deductions /Savings/investment is Rs.5,83,692/-. The balance of his Saving Bank Account(s) decreased for Rs.28,957/- this year. Thus a sum of Rs.6,76,828/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 3.7.14 (flag 'A') which was due to be submitted in the financial year 2014-15 i.e. on before 31.3.15. As such there is no delay in submitting the Property statement from the part of the officer.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto 2011-12 which was seen by Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Bahraich on 21.8.13 at flag 'Z' and the said statement is at flag 'M'.
