May kindly see the letter dated 9.3.17 (flag 'A') by which Sri Avadh Bihari Singh, Special Judge(SC/ST Act), Ghazipur has submitted his statements of movable and immovable properties for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial years 2014-15, Sri Singh, total income from Salary and other Sources is Rs.16,97,035/-(Rs.14,57,035/- from Salary and Rs.2,40,000/- from rent of house) from this amount he has paid Rs.1,33,510/- against GPF, Rs.4800/- against GIS, Rs.1,29,000/- against Income Tax, Rs.2,42,000/- towards Loans, Rs.70,000/- against PPF, Rs.51,902/- against LIC premium. As such, total deductions /Savings/investment is Rs.6,31,468/-. The balance of his Saving Bank Account(s) decreased for Rs.1,07,037/- this year. Thus a sum of Rs.11,72,604/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2014-15.

(2) In the financial years 2015-16, Sri Singh, total income from Salary and other Sources is Rs.18,29,930/-(Rs.14,98,510/- from Salary, Rs.2,40,000/- from rent of house and Rs.91,420/- Income Tax refund)) from this amount he has paid Rs.1,55,974/- against GPF, Rs.4800/- against GIS, Rs.1,44,600/- against Income Tax, Rs.2,44,248/- towards Loans, Rs.1,00,000/- against PPF, Rs.51,902/- against LIC premium. As such, total deductions /Savings/investment is Rs.7,01,524/-. The balance of his Saving Bank Account(s) decreased for Rs.18,106/- this year. Thus a sum of Rs.11,46,512/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2015-16.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Dinesh Gupta, Administrative Judge, Bahraich Judgship at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 9.3.17 (flag 'A') which was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submission of the aforesaid Property statement from the part of the officer.

May, if approved, the statements of movable and immovable property for 2014-15 and 2015-16 of Sri Avadh Bihari Singh, Special Judge(SC/ST Act), Ghazipur may kindly be laid before Hon'ble Mr. Justice Vipin Sinha, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders ?
