In the financial year 2016-17, Sri Singh's Total Income from Salary and other Sources is Rs.19,75,882/- (Rs.17,35,882/- from gross Income from Salary and Rs.2,40,000/- rented income from his house) and total deductions /Savings /investment/repayment of loan against GPF, GIS, Income Tax, PPF, LIC and repayment of Housing loan & the enhancement of Saving Bank Account(s) is Rs.13,06,440/-. Thus a sum of Rs.6,69,442/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2016-17.

In the financial year 2017-18, Sri Singh's Total Income from Salary and other Sources is Rs.21,29,601/- (Rs.16,49,601/- from gross Income from Salary and Rs.4,80,000/- rented income from his house) and total deductions /Savings /investment/repayment of loan against GPF, GIS, Income Tax, PPF, LIC and repayment of Housing loan & the enhancement of Saving Bank Account(s) is Rs.14,58,150/-. Thus a sum of Rs.6,71,451/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2017-18.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 6.3.19( flag 'A') which was due to be submitted in the financial year 2018-19 i.e. on or before 31.3.2019.
