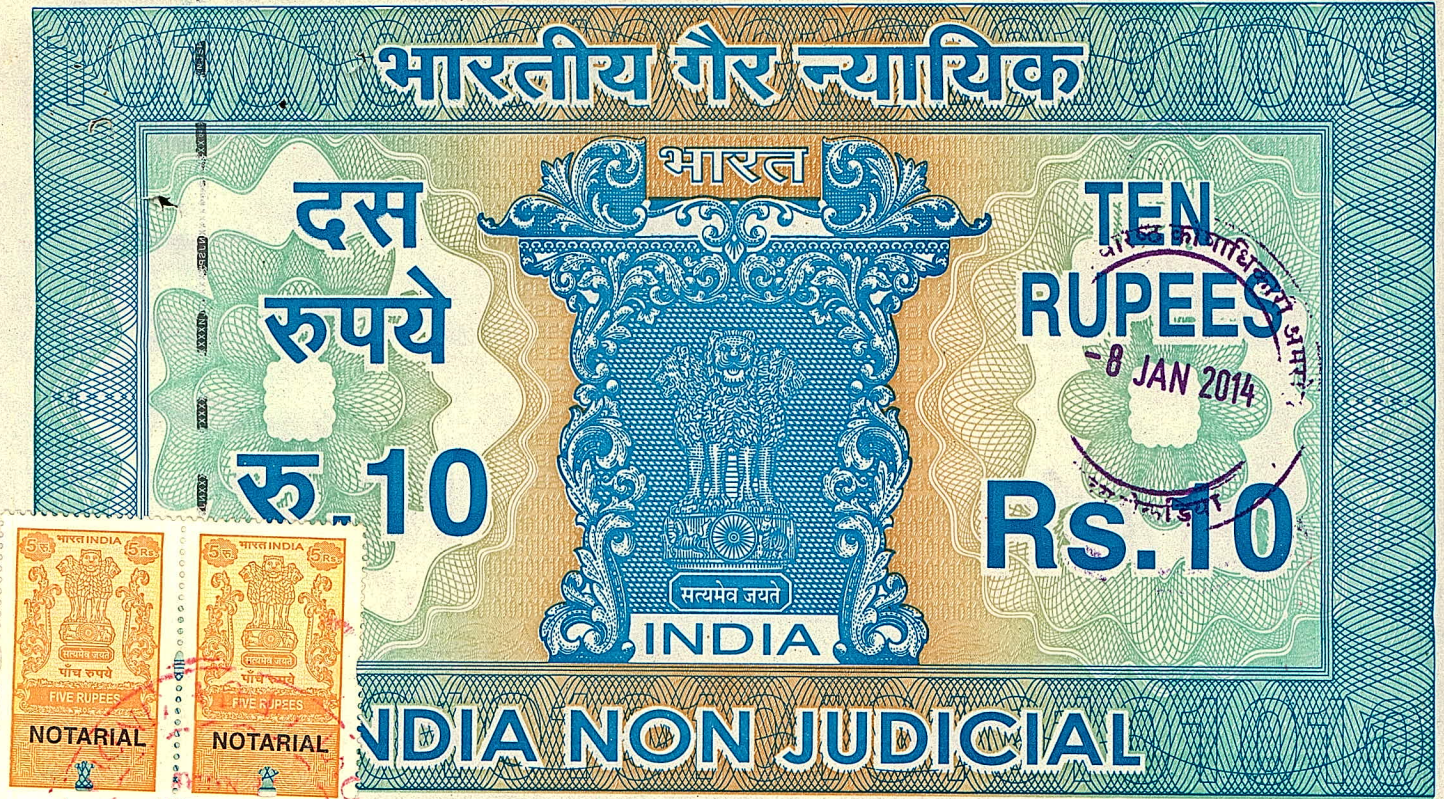

- (l) That the deponent have a son Abhishek Anand aged about 13 years and wife Smt. Reeta Kumari, both are deponent on the deponent.

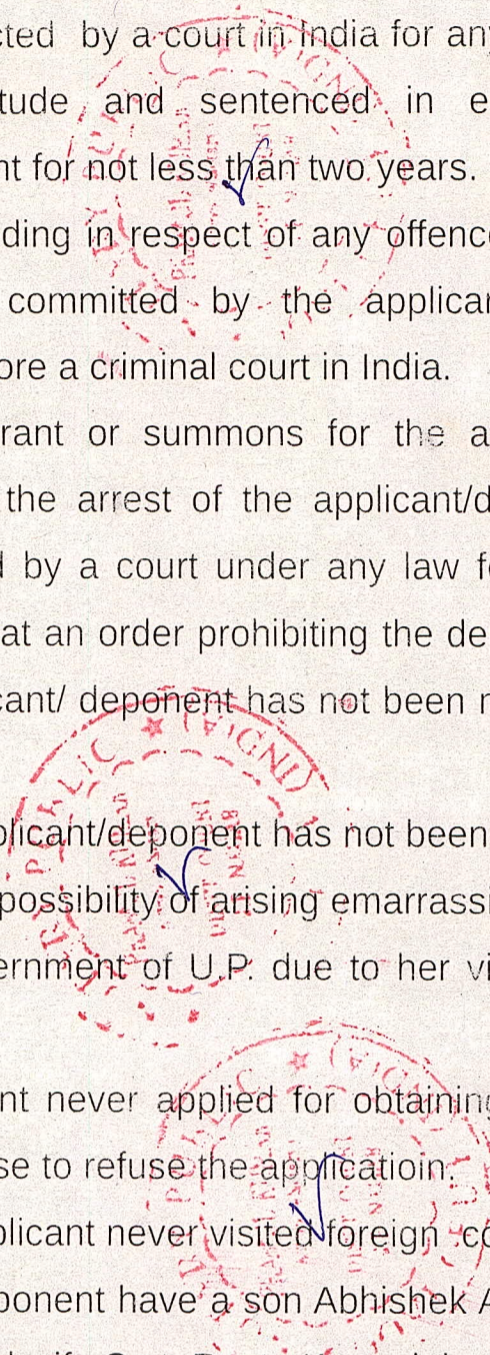
