Chief Judicial Magistrate, Meerut.

In this connection, it is submitted that Sri Bharti has already submitted the statement of movable and immovable properties acquired/held up to Calendar year 2002 which was seen by Hon'ble Mr. Justice V.S.Bajpai, Administrative Judge, Barabanki Judgeship on 01.9.03 vide office note dated 10.7.03 at flag 'Z'.
