May kindly see letter dated 16.03.18(at flag 'A') along with application dated 16.03.2018(at flag 'B') and earlier letter dated 20.12.17(at flag 'C') of Sri Ram Karan-II, Additional District & Sessions Judge, Hardoi regarding sanction of final withdrawal of Rs.15,00,000/- to him out of the total amount standing to his credit in G.P.F Account No. LJU-23465, to mete out expenses relevant with new construction of his house at Plot bearing Khasra No. 1011(Gata no. 416), Village-Bharwara, Gomti Nagar, Lucknow.

Sri Ram Karan-II has informed vide certificate dated 22.02.18(at flag 'D') that he had purchased a plot bearing Khasra no. 1011(Gata no. 416) situated at Village-Bharwara, Gomti Nagar, Lucknow in his own name as well as name of his wife, Mrs. Neelu, after obtaining prior permission from Hon'ble High Court. With respect to construction of house on same, he had obtained loan of Rs.20,00,000/- from State Bank of India, Branch-Akbarpur, Ambedkar Nagar out of which Rs.16,00,000/- have already been spent in getting its preliminary preparations done like boundary wall, septic tank, submersible pump, etc. He has further informed that estimate of total expenses(at flag 'E') to be incurred in proposed construction has also been issued from approved Architect Engineer, Patel Designer & Associate, Vibhuti Khand, Gomti Nagar, Lucknow, thereby depicting his pecuniary circumstances under which he has placed request for said final withdrawal. Besides, he has provided copy of Sale Deed(at flag 'F') of above stated plot in support of his request.

In this connection it is submitted that the aforesaid request of Sri Ram Karan-II may be considered under provision of Rule 16(1)(C)(a) of G.P.Fund(U.P) Rules, 1985, which is as follows :

Rule 16(1)(C) : After the completion of fifteen years of service(including period of suspension followed by reinstatement and other broken periods of service, if any) of a subscriber or within 10 years before the date of his retirement on superannuation, whichever be earlier, from the amount standing to his credit in his GPF Account for one or more of the following purposes, namely:

- (a) **Building or acquiring a suitable house or ready-built flat for his residence including the cost of the site.**

Sri Ram Karan-II has also enclosed self-attested photo-copy of last four including current F.Y. GPF pass-book statements and certificate dated 15.03.18(at flag 'G'), issued by the District Judge, Hardoi, as the evidence of total amount available to his credit till February,18 in GPF Account No. LJU-23465. As per GPF pass-book statement for the F.Y 2016-17(at flag 'H') & 2017-18(at flag 'I') and certificate issued by the District Judge, Hardoi(flagged as 'G'), a total amount of Rs.24,95,927/- stands to his credit in his GPF Account, out of which final withdrawal of Rs.15,00,000/- can be sanctioned to him. He has also informed vide certificate dated 22.02.18(at flag 'J') that he has not taken any Temporary Advance or Final Withdrawal from his GPF Account in his entire service period.

He had joined U.P.Judicial services on 01.10.1999 and is due to retire on 31.01.2022. His current Pay is Rs.57,220/-.

Final Withdrawal of Rs.15,00,000/- may be sanctioned to Sri Ram Karan-II, Additional District & Sessions Judge, Hardoi from his GPF Account No. LJU-23465, to mete out the expenses relevant with new construction of his house at Plot bearing Khasra No. 1011(Gata no. 416), Village-Bharwara, Gomti Nagar, Lucknow, as a special case, in terms of sub rule 16(1)(C)(a) read with 17(1)(a), which allows sanction of withdrawal up to 3/4th of the balance at the credit of officer in the Fund, of G.P.Fund(U.P) Rules, 1985, subject to the following conditions :

1. That the amount shall not be withdrawn unless it is actually required for the purpose and it shall not be utilized for any other purpose.
2. That a utilization certificate shall be furnished to the Court within the time allowed in rule.
