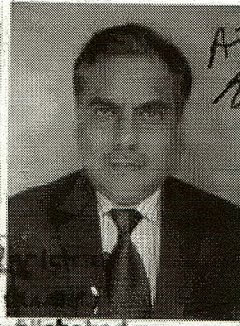
**IDENTITY CERTIFICATE**
