Sir,

With reference to your endt. No.448/I dated 18.2.14 on the above subject, I am directed to say that the Court has been pleased to grant permission to Sri Prafulla Kamal, Judge, Small Causes Court, Kanpur-Nagar to pursue for LL.M. Course from Kurukshetra University, Kurukshetra through Correspondence in the academic session 2013-14 with exemption from compliance of Court's Circular letter no.35/IV-h-16/Admin.(A)/dated 4.11.2011 and without entering into the fact whether the University is recognized by UGC or not and without reserving any future claim of the Officer regarding his qualification if the University is not recognized, subject to the following conditions:-

- (1)Government work should not suffer in any way.
- (2)The academic classes are held outside office hours, if any.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if, it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May kindly see the letters dated 21.12.13 and 17.02.14 at flag 'A' and 'A-1' of Sri Prafull Kamal, Judge, Small Causes Court, Kanpur-Nagar regarding grant of permission to do the LL.M Course through Correspondence from Kurukshetra University, Kurukshetra in the academic Sessions 2013-14.

Sri Kamal in his letters has stated that he wants to do the LL.M. Course through Correspondence from Kurukshetra University, Kurukshetra in the academic Sessions 2013-14 through Correspondence. He assures that as there are no regular classes held for LL.M. Course through Correspondence, there is no chance of suffering of Judicial work performed by him. He has therefore requested for grant of permission to do the LL.M. Course through Correspondence from Kurukshetra University, Kurukshetra in the academic Sessions 2013-14. He has also stated that he will not avail any study leave during doing the aforesaid Course as the same is Correspondence Course.

In this connection it is stated that Sri Kamal has joined the U.P. Judicial Service on 22.3.2001. There is circular letter dated 4.11.11 (flagged 'M') which provides that if any Judicial Officer during the course of his Service, requests to pursue higher studies, he has to apply for grant of 'Study Leave' as per rules which will be subject to the discretion of Hon'ble the Chief Justice. In the instant case, as the course is to be pursued through correspondence there appears to be no necessity to attend any regular classes and as the officer stated himself that there are no regular classes held for LL.M. through Correspondence his request may be considered with exemption for requirement to take study leave. However acceptance of his request is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No.24/1066-Appointment (B) dated 21.08.1967(copy at flag X), subject to the following conditions:-

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved, the file may be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and if His Lordship approves :-

(a) Sri Prafulla Kamal, Judge, Small Causes Court, Kanpur-Nagar may be granted permission to do LL.M Course through Correspondence from Kurukshetra University, Kurukshetra in the academic Sessions 2013-14, with exemption of the requirement to take study leave for the same without entering into the fact whether the University is recognised by UGC or not and without reserving any future claim of the Officer regarding his qualification if the University is not recognised.

(b) to pass any other order which His Lordship deem fit and proper .




