May kindly see the letter dated 23.4.2018 (flagged 'A')) by which Sri Prafulla Kamal, Additional District and Sessions Judge (FTC), Sant Kabir Nagar has submitted his movable and immovable property statement for the financial years 2014-15, 2015-16, 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

- (1) In the financial year 2014-15, of Sri Kamal's Income from Salary and other Sources is Rs.14,77,646/- (Rs.13,46,536 /- income from Salary, Rs.1,31,110/- from Bank interest) and from this amount, Rs.1,74,249/- against GPF, Rs.4800/- against GIS, Rs.16,714/- against LIC, Rs.3,00,000/- against PPF, Rs.87,600/- against PLI, Rs.1,88,081/- against Income Tax, Rs.1,75,000/- against Mutual fund. The balance of his Saving Bank Account(s) enhanced for Rs.14,098/- this year against the balance of previous year. As such, total deductions/ repayment/Savings/investment is Rs.9,60,642/-. Thus a sum of Rs.5,17,004/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.
- (2) In the financial year 2015-16, of Sri Kamal's Income from Salary and other Sources is Rs.14,23,681/- (Rs.13,59,858/- income from Salary and , Rs.63,823/- from Bank interest) and from this amount, Rs.2,09,845/- against GPF, Rs.4800/- against GIS, Rs.16,714/- against LIC, Rs.3,00,000/- against PPF, Rs.87,600/- against PLI, Rs.1,97,020/- against Income Tax, Rs.1,80,000/- against Mutual fund. The balance of his Saving Bank Account(s) enhanced for Rs.9,653/- this year against the balance of previous year. As such, total deductions/ repayment/Savings/investment is Rs.10,05,632/-. Thus a sum of Rs.4,18,049/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.
- (3) In the financial year 2016-17, of Sri Kamal's Income from Salary and other Sources is Rs.15,09,728/- (Rs.14,75,878/- income from Salary and Rs.33,850/- from Bank interest) and from this amount, Rs.1,95,465/- against GPF, Rs.4800/- against GIS, Rs.16,714/- against LIC, Rs.3,00,000/- against PPF, Rs.87,600/-

against PLI, Rs.2,24,737/- against Income Tax, Rs.2,30,000/- against Mutual fund. The balance of his Saving Bank Account(s) enhanced for Rs.55,969/- this year against the balance of previous year. As such, total deductions/ repayment/Savings/investment is Rs.11,15,285/-. Thus a sum of Rs.3,94,443/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.

- (4) In the financial year 2017-18, of Sri Kamal's Income from Salary and other Sources is Rs.16,51,704/- (Rs.16,49,130/- income from Salary and Rs.2574/- from Bank interest) and from this amount, Rs.2,30,412/- against GPF, Rs.4800/- against GIS, Rs.16,714/- against LIC, Rs.3,00,000/- against PPF, Rs.87,600/- against PLI, Rs.2,45,000/- against Income Tax, Rs.1,80,000/- against Mutual fund. ————— As such, total deductions/ repayment/Savings/investment is Rs.10,64,526/-. The balance of his Saving Bank Account(s) decreased for Rs.89,013/- this year against the balance of previous year. Thus a sum of Rs.6,76,191/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

The movable and immovable property statement for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 23.4.18 (flagged 'A'). Property statement for the financial years 2014-15 and 2015-16 was due to be submitted in third financial years 2016-17 and Property statement for the financial years 2016-17 and 2017-18 was due to be submitted in third financial years 2018-19. As such there is delay in submitting the Property statement for the financial years 2014-15 and 2015-16 from the part of officer for which officer has stated that due to his transfer from Kanpur-Nagar to Sant Kabir Nagar and his business in his family affairs, he could not submit the same in due time.

It is pertinent to mention here that the wife of the officer Smt. Meena Srivastava is Civil Judge(Sr.Div.), Kanpur-Nagar / Additional District and Sessions Judge, Kanpur Nagar and Sant Kabir Nagar/Judicial Member, Commercial Tax Tribunal, Gorakhpur and her annual income is Rs.10,35,080/-(in the financial year 2014-15), Rs.13,59,088/-(in the financial year 2015-16), Rs.16,20,834/-(in the financial year 2016-17) and Rs.17,92,276/-(in the financial year 2017-18).

In this connection it is submitted Sri Kamal had already submitted his property statement upto financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Tarun Agarwala, , the then Administrative Judge, Kanpur-

Nagar Judgeship on 22.12.14, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 of Sri Prafulla Kamal, Additional District and Sessions Judge (FTC), Sant Kabir Nagar may kindly be laid before Hon'ble Mr. Justice Rajiv Lochan Mehrotra, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
