May kindly see the letter dated 22.3.11 at flag 'A' by which Sri Ramesh Kumar Yadav, Civil Judge(Sr.Div.), Ramabai Nagar(Kanpur-Dehat) regarding delay in submission of property statement.

Earlier Sri Yadav has submitted his property statement for the Calendar Year 2001 and 2002 in the matter of purchase of Car vide his letter dated 11.9.2003 (at flag 'B') in the matter of purchase of Revolver. When he submitted his property statement for the Calendar 2006 vide his letter dated 1.2.07 (at flag 'C') then he was asked to send his property statement for the Calendar Year 2003 as well as financial year 2004-05 and 2005-06 vide Court's letter dated 3.4.07 and 12.3.08(at flag 'D' and 'E') which is required vide Court's Circular letter dated 10.12.98 and 13.5.04. In reply of aforesaid Court's letters, Officer has submitted his property statement for the Calendar Year 2003 as well as financial year 2004-05 and 2005-06 vide his letter dated 23.4.08(at flag 'F'). In the meantime property statement for the financial year 2006-07 and 2007-08 was also due then a Court's letter dated 31.5.08 (flag 'G') was send to the officer to send his property statement for the financial year 2006-07 and 2007-08 and property statement at the time of entering into Judicial Service but as the officer has submitted his property statement for the Calendar Year 2001 so that statement of at the time of entering into Judicial Service was not required. In the meantime Sri Yadav has submitted his property statement for the ^{Calendar year 2007} financial year ~~2006-07~~ ^{2008-09 & 2008-10} and 2007-08, vide his letter dated 15.11.10(at flag 'H'). Again a Court's letter dated 15.3.11(flag 'K') was send to the officer for stating reasons for not submitting the aforesaid statement in due time. In reply of the aforesaid Court letter , Officer has submitted reply vide his letter dated 22.3.11 (at flag 'A').

Now all the property statement for the Calendar Year 2001, 2002, 2003 and financial year 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 and 2009-10 (flag I,II, III, IV, V, VI, VII, VIII and IX) are in the file. There is some delay in submission of property statement for the Calendar Year 2003 and financial year 2004-05, 2005-06, 2006-07 and 2007-08 which was due to be submitted in the Calendar Year 2004 and financial year 2006-07 and 2008-09 for which Officer has stated that on account of late receiving of relevant records from different Judgeships due to transfer, he could not be able to submit the desired statements well in time and has further stated that such mistake was not made by him deliberately and has assured that such type of mistakes will not be repeated by in future.

If ,approved, the file may be laid before Hon'ble Mr. Justice Imtiyaz Murtaza, Administrative Judge, Ramabai Nagar(Kanpur-Dehat) for kind kperusal and orders ?
