May kindly see the letter, placed below at flag 'A' , received from Sri Ramesh Kumar Yadav, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13, the income from salary is Rs.8,79,902/-, income from arrears is Rs.1,18,136 and income from other sources is Rs. 1,00,000/-. Thus the total income is Rs.10,98,038/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,09,748/- against GPF, Rs.1,02,338/- against Income Tax, Rs.15,290/- against Car loan, Rs.65,695/- against Premium of LIC policies and Rs.25,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.69,403/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.3,92,274/-. Thus, a sum of Rs. 7,05,764/- was therefore available with him to meet out the household expenditure of his family consisting of six members in whole of the financial year.

(2) In the financial year 2013-14, the income from salary is Rs.10,50,780/-, income from arrears is Rs.4,14,811 and income from other sources is Rs. 1,25,000/-. Thus the total income is Rs.15,90,591 and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,17,181/- against GPF, Rs.1,23,500/- against Income Tax, Rs.90,695/- against Premium of LIC policies and Rs.10,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.2,55,803/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.6,01,979/-. Thus, a sum of Rs. 9,88,612/- was therefore available with him to meet out the household expenditure of his family consisting of six members in whole of

the financial year.

In this connection it is submitted that Sri Ramesh Kumar Yadav has already submitted his property statement upto the financial year 2011-12 (statement is at flag 'B') which had already been seen by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow on 18.10.2014 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-13 & 2013-14 in its next financial year i.e., in 2014-15 up to March 2015. He has submitted the movable and immovable property statement for the financial year 2012-13 vide his letter dated 01.10.2013 (at flag 'B') & property statement for the financial year 2013-14 vide his letter dated 09.10.2015 (at flag 'A'). As such, there is delay in submitting the aforesaid statements.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letters dated 09.10.2015 (at flag 'A') and 01.10.2013 (at flag 'B') of Sri Ramesh Kumar Yadav, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Vikram Nath, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
