May kindly see the letters, placed below at flag 'A' & 'B', received from Sri Ramesh Kumar Yadav, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2013-14, 2014-15, 2015-16 and 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, savings investment and expenditure made by her are given below.

(1) In the financial year 2014-15, the income from salary is Rs.11,90,510/-, income from arrears is Rs.30,656/- and agricultural income is Rs.1,25,000/-. Thus, the total amount is Rs.13,46,166/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,05,456/- against GPF, Rs.1,37,577/- against Income Tax, Rs.64,855/- against premium of LIC policies, Rs.25,840/- against PLI and Rs.10,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.1,10,193/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.4,58,721/-. Thus, a sum of Rs.8,87,445/- was therefore available with him to meet out the household expenditure of his family consisting of six members in whole of the financial year.

(2) In the financial year 2015-16, the income from salary is Rs.13,31,184/- (including D.A./Arrear) and agricultural income is Rs.1,25,000/-. Thus, the total amount is Rs.14,56,184/- and from this

amount, Rs.4,800/- is deducted against GIS, Rs.1,75,229/- against GPF, Rs.1,69,802/- against Income Tax, Rs.64,855/- against premium of LIC policies, Rs.25,840/- against PLI and Rs.10,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.4,50,526/-. Thereafter, a sum of Rs.4,50,526/- was appears to be in his hand to meet out the household expenditure of his family consisting of five members in whole of the financial year. Besides this, balance amount of his S.B.account(s) is also decreased in this year for Rs.7,25,031/- from previous year's balance.

In this connection it is submitted that Sri Ramesh Kumar Yadav has already submitted his property statement upto the financial year 2013-14 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Vikram Nath, the then Administrative Judge, Lucknow on 21.03.2014 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., in 2016-17 upto March 2017. He has submitted the movable and immovable property statement for the financial year 2014-15 vide his letter dated 09.10.2015 (at **flag 'B'**) and 2015-16 vide his letter dated 19.04.2017 (at **flag 'A'**). As such, there is delay in submitting the property statement for the financial year 2015-16 from the part of the officer.

In this connection, it is also submitted that Sri Ramesh Kumar Yadav has also submitted property statement for the financial year 2016-17 through his letter dated 19.04.2017 (at **flag 'A'**), but as per two years block policy, the same will be taken up for consideration alongwith the statement of 2017-18, which will be submitted by the officer in near future.
