May kindly see the letters, placed below at flag 'A' & 'A-1' received from Sri Ramesh Kumar Yadav, Additional District & Sessions Judge, Lucknow regarding permission to sell his old Hyundai I-10 car.

In this letters, Sri Yadav has stated that he is the owner of Hyundai I-10 car bearing reg. no. UP 70 AV 4123 which is outdated now. The insured price of the said car is Rs. 1,50,000/- & he had duly applied for grant of permission for sale of the said car to M.G.S. Infrabuild Pvt. Ltd. to Hon'ble Court on 08.04.2016. But due to some unavoidable circumstances it is not possible to purchase new car from M.G.S. Infrabuild Pvt. Ltd. Therefore, he entered into a fresh agreement with Sri Daya Shankar Pandey, S/o Sri Bhanu Pratap Pandey, R/o 559 Kha-1/173, Shrinagar Shriangar Alambagh, Lucknow. In the proposed agreement the purchaser, Sri Pandey has given an A/c payee cheque of Rs. 1,30,000 which can be cashed after the transfer of the said Hyundai I-10 car in his (purchaser) favour (copy of Agreement & cheque are at flags 'B' and 'C' respectively). He has further stated that he is neither related to him in any manner nor any of his case is decided or pending in his Court. Therefore, he has requested to place his application before the Hon'ble High Court to sell his old Hyundai I-10 car, bearing reg. no. UP 70 AV 4123 to the proposed purchaser namely Sri Daya Shankar Pandey for Rs. 1,30,000/-.

In this connection, it is submitted that the officer had duly informed about purchase of the car in the year 2008 and the same was seen by Hon'ble Judge on 18.09.2008 (Order is at flag 'X'). The same car was also shown in his property statements. The relevant Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956 relating to transfer of movable property are as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

Under the facts & circumstances mentioned above if approved, the file may be laid before Hon'ble Mr. Justice Manoj Misra, Nominated Judge for disposal of the matters of Judicial Officers, of information/ permission of sale/ purchase of movable/ immovable property or gift etc. for His Lordship's kind perusal and if His Lordship's approves, Sri Ramesh Kumar Yadav, Additional District & Sessions Judge, Lucknow be granted permission to sell his Hyundai I-10 car bearing reg. no. UP 70 AV 4123 to Sri Daya Shankar Pandey, S/o Sri Bhanu Pratap Pandey, R/o 559 Kha-1/ 173, Shrinagar Shriangar Alambagh, Lucknow for a sum of Rs. 1,30,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
