May kindly see the letter, placed below at flag 'A' received from Sri Ramesh Kumar Yadav, Additional District Judge (F.T.C.), Chandauli regarding grant of permission to sell off his old DBBL Gun and purchase of a new SBBL Gun from B.S.A., Corporation, Allahabad.

In his letter, Sri Yadav has stated that he is the owner of DBBL Gun no. 4449/94 covered under Arms licence no. 9499 P.S. Handiya dated 11.03.1995, issued by D.M., Allahabad. But the said firearm has become old and so he intends to sell it off and purchase a new firearm i.e. SBBL Gun. Furthermore, it is also submitted that B.S.A. Corporation (Arms & Ammunition Dealer) 40 Vivekanand Marg, Allahabad has agreed to purchase his old DBBL Gun for Rs. 2,000/- & sell off new SBBL Gun to him for Rs. 75,000/- while the District Magistrate, Chandauli has also provided him three months time to sell his old firearm & purchase new one (copy of 'original Consent letter' of the corporation & 'sale invoice' is at flag 'B'). Therefore, the officer has requested for grant of permission to sell his old DBBL Gun and purchase a new SBBL Gun.

In this connection, it is submitted that according to this Court's C.L. no. 11/ Ivh-16/ Admin (A) dated 12.04.2010 (copy at flag 'C'), the officer is required to take permission of this Court to purchase/sell a firearm, for which he has requested. However, permission of the Court is not required to obtain licence and only permission to purchase a firearm is required to take from this Court, for which he has also requested. Seeing his designation and need, his case may be considered favourably and, if his case for grant of permission is considered favourably, it may be with a condition that he shall submit full details about sale of DBBL Gun and purchase of a SBBL Gun, immediately after its purchase, alongwith all the relevant papers.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Manoj Misra for His Lordship's kind perusal and orders?
