May kindly see the letter, placed below at flag 'A' received from Sri Ramesh Kumar Yadav, the then Additional District Judge, Chandauli presently posted as Principal Judge, Family Court, Chandauli regarding grant of permission to sell off his old 0.32 bore revolver in exchange of a new pistol from Shukla Gun House, Lucknow.

In his letter, Sri Yadav has stated that he is the owner of 0.32 bore revolver no. A900A covered under Arms licence no. 9835/G.S./2011 P.S. Nawabganj, Kanpur Nagar dated 03.12.2011, issued by D.M., Kanpur. But as the barrel of the said revolver is too big, it is quite difficult to carry it along with him. Therefore, he intends to sell it off and purchase a new pistol. The said revolver has been purchased by sale of his old 32 bore Revolver no. C-5856. Intimation has been duly submitted by the officer (flagged 'X'). Furthermore, it is also submitted that Shukla Gun House, Lucknow has agreed to purchase his old revolver in exchange of new pistol without any cost & while the District Magistrate, Chandauli has also provided him three months time to sell his old firearm in exchange of new one (copy of 'original Consent letter' of the dealer & licence is at flag 'B'. Therefore, the officer has requested for grant of permission to sell his old 0.32 bore revolver in exchange of a new pistol.

In this connection, it is submitted that according to this Court's C.L. no. 11/ lvh-16/ Admin (A) dated 12.04.2010 (copy at flag 'C'), the officer is required to take permission of this Court to purchase/sell a firearm, for which he has requested. However, permission of the Court is not required to obtain licence and only permission to purchase a firearm is required to take from this Court, for which he has also requested. Seeing his designation and need, his case may be considered favourably and, if his case for grant of permission is considered favourably, it may be with a condition that he shall submit full details about sale of 0.32 bore revolver in exchange of a new pistol, immediately after its purchase, along with all the relevant papers.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Manoj Misra for His Lordship's kind perusal & if His Lordship approves, Sri Ramesh Kumar Yadav, Principal Judge, Family Court, Chandauli be accorded permission to sell his old 0.32 bore revolver in exchange of a new pistol from Shukla Gun House, Lucknow, as requested, subject to the condition that he will submit full pointwise details and papers of the purchase after completion of the purchase transaction immediately, under C.L. no. 25/ Admin
