May kindly see the letters placed below at flag 'A' & 'A-I', received from Sri Babu Ram, Civil Judge (Sr. Div.), Faizabad, regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial year 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Babu Ram had submitted his movable & immovable property statement for the financial years 2010-11 & 2011-12 through his letter dated 22-06-2013 (flagged 'A-I') but he has mentioned the details of GPF, GIS, HRA, IncomeTax and other investment separately in column no. 8 of the proforma in the movable property statement of the financial year 2011-12. Thereafter he was asked to send the above information vide Court's letter dated 03-08-2013 (flagged 'C'). In reply of Court's letter Sri Babu Ram has sent letter dated 27-08-13 (flagged 'A') by which he has submitted the reply of Court's letter after mentioning the above information.

In this connection it is submitted that from perusal of the aforesaid property statement it appears the in the financial year 2010-11 Sri Babu Ram's total income (from salary and arrears) was Rs.8,39,044/- from this amount his deductions was Rs.1,06,746/- GPF, Rs.2560/- GIS, Rs.32,258/- deposited as LIC premium, Rs.54,136/- deducted as Income Tax, Rs.75,600/- paid as car loan, Rs.51,750/- (including interest) deposited in PPF account and Rs.1,68,219/- (including interest) deposited in his savings bank account. Total deductions and investment is Rs.04,91,549/-. Thus a sum of Rs.3,47,495/- was therefore available to him to meet out his family (five members) expenditure in whole financial year 2010-11.

In the financial year 2011-12 Sri Sri Babu Ram's total income (from salary and arrears) was Rs.18,42,491/- from this amount his deductions was Rs.2,33,924/- GPF, Rs.4800/- GIS, Rs.32,258/- deposited as LIC premium, Rs.2,92,000/- deducted as Income Tax, Rs.75,600/- paid as car loan, Rs.91,534/- (including interest) deposited in PPF account and Rs.3,09,903/- (including interest) deposited in his savings bank account. Total deductions and investment is Rs.10,40,019/-. Thus a sum of Rs.8,02,472/- was therefore available to him to meet out his family (five members) expenditure in whole financial year 2011-12.

In this connection it is submitted that Sri Babu Ram has already submitted his property statement up to financial years 2009-10 which has already been seen by Hon'ble Mr. Justice V. K. Shukla, the then Administrative Judge Bagpat

on 04-07-2012 at flag 'Z'. The said property statement for the financial year 2009-10 is at flag 'M'.

The instant statement submitted by the officer for the financial years 2010-11 & 2011-12 through his letter dated 22-06-2013 (flagged 'A') which was due to be submitted in third financial year accordingly i.e. 2012-13, which was end up on 31-03-2013. As such there is some delay in submitting the property statement.

May, if approved the statement of movable and immovable property for the financial year 2010-11 & 2011-12 of SriBabu Ram, Civil Judge (Sr. Div.), Faizabad, be laid before Hon'ble Mr. Justice Abdul Mateen, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
