May kindly see the letter dated 18.9.2015 (at flag 'A') of Sri Babu Ram, Additional District and Sessions Judge, Lakhimpur-Kheri by which he has submitted his movable and immovable property statements for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Sri Babu Ram's Gross Income is Rs.11,28,081/- from this amount, he has paid Rs.99,258/- against GPF, Rs.4,800 against GIS, Rs.1,00,105/- against Income Tax, Rs.32,548/- against LIC, RS.1,00,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,36,711/-. The balance of his Saving Bank Account(s) decreased for Rs.4,11,356/ this financial year. Thus a sum of Rs.12,02,726/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Sri Babu Ram's Gross Income is Rs.11,03,421/- from this amount, he has paid Rs.98,481/- against GPF, Rs.4,800 against GIS, Rs.1,23,460/- against Income Tax, Rs.32,548/- against LIC, RS.1,00,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,59,289/-. The balance of his Saving Bank Account(s) decreased for Rs.95,115/ this financial year. Thus a sum of Rs.7,44,132/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2013-14.

The movable and immovable property statement for the financial year 2012-13 and 2013-14 been submitted by the officer vide his letter dated 18.9.2015 (flag 'A') which was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the aforesaid Statements from the part of the officer.

In this connection, it is submitted that Sri Babu Ram has already submitted his property statement upto financial year 2011-12 which was seen by Hon'ble Mr. Justice Abdul Mateen , the then Administrative Judge, Faizabad Judgeship on 13.12.2013 at flag 'Z' and
