May kindly see the letters, placed below at **flags 'A' & 'B'** respectively, received from Sri Babu Ram, Additional District & Sessions Judge, Varanasi regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Babu Ram has submitted his movable & immovable property statements for the financial years 2014-15 & 2015-16 through his letter dated 11.09.2018 (at **flag 'B'**) in which he has not submit the balance of his SB a/cs at the end of the financial years & amount deposited in PPF a/c in movable statement of the financial year 2015-16. Then a Court's letter dated 22.12.2018 (at **flag 'C'**) has been sent to the District Judge, Varanasi with the request to kindly ask the officer to submit the required information alongwith reason of delay of late submission of the aforesaid statements, to the Court at the earliest, so that necessary action may be taken in the matter.

The officer has submitted revised movable property statement of the financial year 2015-16 through his letter dated 09.01.2019 (at **flag 'A'**).

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2014-15, income from salary is Rs.12,32,169/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.86,423/- against GPF, Rs.1,31,031/- against Income Tax, Rs.96,474/- against premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.15,154/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.4,33,882/-. Thus, a sum of Rs.7,98,287/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(2) In the financial year 2015-16, income from salary is Rs.13,09,330/- and from this amount, Rs.4,400/- is deducted against GIS, Rs.86,894/- against GPF, Rs.1,23,674/- against Income Tax, Rs.96,474/- against premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.33,471/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.4,44,913. Thus, a sum

of Rs.8,64,417/- was therefore available with him to meet out the household expenditure of of his family consisting of five members in whole of the financial year.

In this connection it is submitted that Sri Babu Ram has already submitted his property statement upto the financial year 2013-14 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Kheri at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017. He has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 firstly vide his letter dated 11.09.2018 (at **flag 'B'**). As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has regretted.

May, therefore, if approved, property statements for the financial years 2014-15 & 2015-16 alongwith letters dated 09.01.2019 and 11.09.2018 (at **flags 'A' & 'B'** respectively) of Sri Babu Ram, Additional District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice B.Amit Sthalekar, Administrative Judge, Varanasi for His Lordship's kind perusal and orders?
