It may be recalled that District Judge Thansi sent the above said Transfer T. A bill to this Court through his letter No 1783 / IX dated 16-9-05 (flagged 'B') in which several objections were found. As such the said Transfer T. A bill was returned through Court's letter No. 349 / IV-2918 / Admin A dated 7-1-06 (flagged 'C') with the remark to resubmit the same after removing objections.

In reply of Court's letter dated 7-1-2006 the District Judge, Thansi has removed objections pointed out in Court's letter dated 7-1-2006. Vide his letter No 262 / XV dated 23-2-2006 (flagged 'D')

It is pertinent to mention here that Sri Babu Ram has claimed fare for his parent which are not totally dependent upon him. As such the above said T. A bill was again returned through Court's letter No 5276 / IV-2918 / Admin A dated 21-4-06 (flagged 'E') with the remark to resubmit the same after making correction. In reply of the Court's letter dated 21-4-06. The District Judge Thansi has submitted the T. A bill of Sri Babu Ram, Civil Judge (Junior Division) Thansi after correction and

has also mentioned following three certificates on the T.A bill of Sri Babu Ram

- (A) - The claim is genuine, admissible and is in order
- (B) It is being claimed for the first time and has not drawn before
- (C) The necessary entries have been made in the office record in such a way that double drawn not be possible

On the basis of the above three certificates of the District Judge, Thansi office has checked the aforesaid Transfer T.A bill of Sri Babu Ram and found to be correct. Pre-audit sanction can be accorded in terms of G.O NO. A-1-2925/X-3(6)/65 dated 18-9-1985 read with G.O NO A-1-3959/X-3/1-(6)65 dated 23-1-1986

Jain for according pre-audit sanction of Transfer T.A bill amounting to Rs 10691 = 00 for the month of June 2004 of Sri Babu Ram, Civil Judge (Junior Division) Meerapur, Thansi.
