May kindly see the letter, placed below at flags 'A', received from Sri Babu Ram, Additional Chief Judicial Magistrate, Faizabad regarding grant of permission to purchase immovable property i.e. 2400 sq. feet of plot, out of Khasra no. 393, situated at Village-Semra, Tehsil- Sadar, District- Gorakhpur.

In his letter, Sri Babu Ram has stated that he has no immovable property in his name and he has also not purchased any immovable property till now. It is submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rules 1956: -

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and if His Lordship's approves, Sri Babu Ram, Additional Chief Judicial Magistrate, Faizabad be accorded permission to purchase 2400 sq. feet of plot, out of Khasra no. 393, situated at Village- Semra, Tehsil- Sadar, District- Gorakhpur, from Sri Paras, S/o Sri Moti Lal, R/o Village- Semra, Tehsil- Sadar, District- Gorakhpur for Rs. 10,05,600/-, as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?
