May kindly see the letter, placed below at **flag 'A'**, received from Sri Intakhab Alam, Additional District & Sessions Judge, Basti regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the income from salary is Rs.13,04,392/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.3,04,725/- against GPF, Rs.1,85,710/- against Income Tax, Rs.24,878/- against Premium of LIC policy and Rs.32,786/- (including interest) deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.2,18,271/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.7,71,170/-. Thus, a sum of Rs.5,33,222/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(2) In the financial year 2011-12, the income from salary is Rs.11,08,823/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,00,060/- against GPF, Rs.1,54,507/- against Income Tax, Rs.24,878/- against Premium of LIC policy and Rs.22,962/- (including

interest) deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.3,07,207/-. The balance of his savings bank account(s) reduced for Rs.63,791/- this financial year. Thus, a sum of Rs.8,65,407/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(3) In the financial year 2012-13, the income from salary is Rs.12,51,897/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.99,939/- against GPF, Rs.1,04,779/- against Income Tax, Rs.24,878/- against Premium of LIC policy and Rs.26,258/- (including interest) deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.2,60,654/- The balance of his savings bank account(s) reduced for Rs.32,774/- this financial year. Thus, a sum of Rs.10,24,017/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(4) In the financial year 2013-14, the income from salary is Rs.11,20,783/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,32,905/- against GPF, Rs.1,28,478/- against Income Tax, Rs.24,878/- against Premium of LIC policy and Rs.33,301/- (including interest) deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.1,62,653/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.4,87,015/-. Thus, a sum of Rs.6,33,768/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(5) In the financial year 2014-15, the income from salary is Rs.13,39,220/- and from this amount, Rs.4,800/- is deducted against

GIS, Rs.1,27,210/- against GPF, Rs.1,70,904/- against Income Tax, Rs.24,878/- against Premium of LIC policy and Rs.36,271/- (including interest) deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.3,64,063/-. The balance of his savings bank account(s) reduced for Rs.2,25,922/- this financial year. Thus, a sum of Rs.12,01,079/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(6) In the financial year 2015-16, the income from salary is Rs.14,42,302/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.91,665/- against GPF, Rs.2,03,282/- against Income Tax and Rs.24,878/- against Premium of LIC policy. The balance of his savings bank account(s) enhanced for Rs.68,845/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.3,93,470/-. The balance of his PPF account reduced for Rs.63,909/- this financial year. Thus, a sum of Rs.11,12,741/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

In this connection it is submitted that Sri Intakhab Alam has already submitted his property statement upto the financial year 2009-10 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice B. N. Shukla, the then Administrative Judge, Bhadohi on 09.11.2010 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2010-11 & 2011-12 in its next financial year i.e., 2012-13 upto march 2013, 2012-13 & 2013-14 in its next financial year i.e., 2014-15 up to March 2015 and 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017 . He has submitted the movable and immovable property statement for the financial

year 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 vide his letter dated 19.04.2016(at flag 'A'). As such, there is delay in submitting the property statements of the financial year 2010-11, 2011-12, 2012-13 and 2013-14 from the part of the officer for which he has stated that due to some unavoidable circumstances relating to the property in the said financial years could not be sent in time, hence delay in this regard is highly regretted in his letter dated 19.04.2016 (at flag 'A').

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 alongwith letter dated 19.04.2016 (at flag 'A') of Sri Intakhab Alam, Additional District & Sessions Judge, Basti be laid before Hon'ble Mr. Justice Vipin Sinha, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
