Most respectfully I beg to state that during my posting in Bhadohi District I had applied for an Arm license to District Magistrate, Bhadohi on 27<sup>th</sup> March, 2010 and it was issued by him on 13<sup>th</sup> April, 2010. Pursuant to the license, I have to purchase firearm (Revolver) for which as per Circular Letter No. II/IV H-16/Admin (A)/ dated 12-04-2010 of the Hon'ble Court, prior permission from the Hon'ble Court is required.
