May kindly see the letters, placed below at flags 'A' & 'A-1', received from Sri Intekhab Alam, Special Additional Chief Judicial Magistrate, C.B.I. (Ayodhya Prakaran), Lucknow regarding grant of permission to purchase a firearm (Revolver).

In his letters, Sri Intekhab Alam has stated that during his posting in Bhadohi District, he had applied for an Arm License to District Magistrate, Bhadohi on 27th March 2010 and it was issued by him on 13th April 2010. Pursuant to the license, he has to purchase firearm (Revolver) for which as per Circular Letter no. 11/ IVh-16/ Admin(A) dated 12.04.2010 of the Hon'ble Court, prior permission from the Hon'ble Court is required. It is pertinent to mention that as per aforesaid Circular letter, application for obtaining permission for purchase of firearm is required to be moved before the Hon'ble Court simultaneously with the submission of application for grant of such license, but he could not submit application for permission for purchase of firearm before the Hon'ble High Court at the time of submission of application for grant of license as the aforesaid Circular letter had been issued by the Hon'ble High Court after submission of application for grant of license to the District Magistrate, Bhadohi. In such circumstances, if the delay is occasioned, the same is highly regretted. He has also submitted copies of License and application for issuance of license (flag 'B' & 'B-1') as well as required details in the light of directions contained in Court's C.L. no. 25/ Admin (A) dated 13.07.1998 and has requested that his application may kindly be placed before the Hon'ble High Court for granting permission for purchase of firearm (Revolver) in pursuance of license issued by the District Magistrate, Bhadohi.

The information regarding transaction of the firearm, as required under Courts Circular Letter No. 25/ Admin (A) dated 13.07.1998 as furnished by the officer is given below: -

It is submitted that as per Rule- 24 (2) of U.P. Government Servant's conduct Rules, 1956: -

"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority:

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Imtiyaz Murtaza Sri Intekhab Alam, Special Additional Chief Judicial Magistrate, C.B.I. (Ayodhya Prakaran), Lucknow be accorded permission to purchase a firearm (Revolver), as requested, subject to the condition that the relevant papers of the transaction be furnished by him immediately on completion of the transaction?
