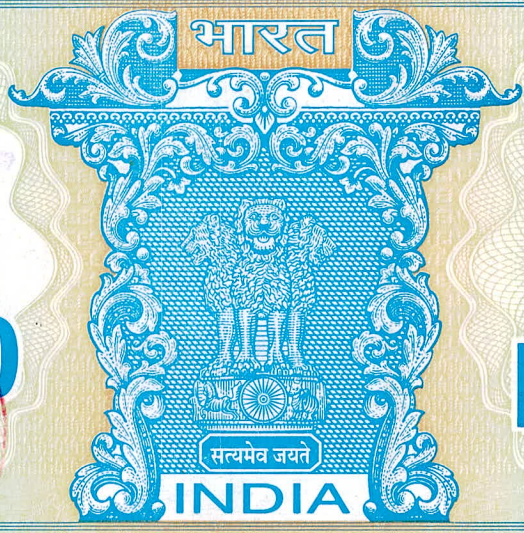

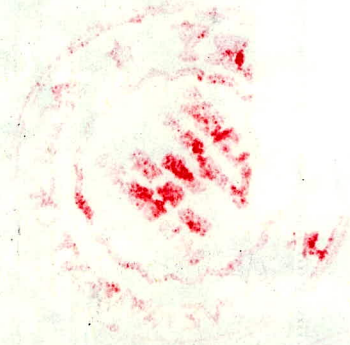

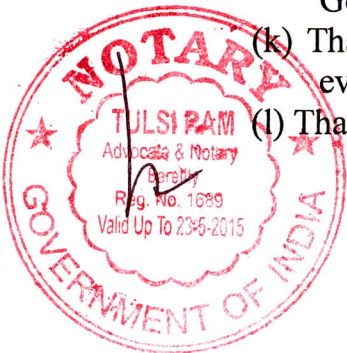

- (d). That the departure of the applicant from India may not or is not likely to be detrimental to the security of India.
- (e). That the presence of applicant outside India may not, or is not likely to prejudice the friendly relations of India with any foreign country.
- (f). That the applicant has at any time during the period of five year immediately preceding the date of his application not being convicted by a Court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (g) That proceedings in respect of any offence at alleged to have not been committed by the applicant are pending before a criminal court in India.
- (h) That a warrant or summons for the appearance or a warrant for the arrest of the applicant has not been issued by a Court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.

- (j) There is no possibility of arising embarrassing position before the Government of U.P. due to his visit to any foreign country.
- (k) That issue of 'Identity Certificate' for obtaining a passport was not ever refused to me..
