May kindly see the letter, placed below at flag 'A' received from Sri Pankaj Misra, Chief Judicial Magistrate, Kanpur Dehat regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2006-07, 2007-08, 2008-09, 2009-10, 2010-11 and 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2006-07, 2007-08, 2008-09, 2009-10, 2010-11 and 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2006-07, the income from salary, agricultural income and other allowances is Rs.04,51,059/- and from this amount, Rs.35,787/- is deducted against GPF, Rs.1440/- against GIS, Rs.40,242/- against LIC, Rs.13,000/- against Income Tax and Rs.50,000/- against HDFC policy and Rs.64,000/- deposited in PPF account. As such, total deductions/repayment/savings/ investment is Rs.02,04,469/-. Thus, a sum of Rs.02,46,590/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2006-07.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.1,292/, against balance of previous year.

(2) In the financial year 2007-08, the income from salaryagricultural income and other allowances is Rs.04,14,435/- and from this amount, Rs.44,545/- is deducted against GPF, Rs.1440/- against GIS, Rs.40,541/- against LIC, Rs.21,431/- against Income Tax and Rs.50,000/- against HDFC policy and Rs.1,10;000/- deposited in PPF account. As such, total deductions/repayment/savings/ investment is Rs.02,67,957/-. Thus, a sum

of Rs.01,46,478/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2007-08.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.26,645/- against balance of previous year.

agricultural income and other allowances is Rs.04,54,420/-, and from this amount, Rs.40,736/- is deducted against GPF, Rs.1440/- against GIS, Rs.40,541/- against LIC, Rs.13,630/- against Income Tax and Rs.50,000/- against HDFC policy and Rs.70,000/- deposited in PPF account. As such, total deductions/repayment/savings/ investment is Rs.02,16,347/-. Thus, a sum of Rs.02,38,073/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2008-09.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.44,047/- against balance of previous year.

- (4) In the financial year 2009-10, the income from salary, agricultural income and other allowances is Rs.05,67,043/- and from this amount, Rs.54,210/- is deducted against GPF, Rs.1440/- against GIS, Rs.40,541/- against LIC, Rs.19,270/- against Income Tax and Rs.70,000/-deposited in PPF account. The balance of his savings bank account (s) enhanced for Rs.1,19,735/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.03,05,196/-. Thus, a sum of Rs.02,61,847/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2009-10.
- (5) In the financial year 2010-11, the income from salary and other allowances is Rs.13,95,443/- and from this amount, Rs.2,71,799/- is

deducted against GPF, Rs.1440/- against GIS, Rs.40,541/- against LIC, Rs.1,94,940/- against Income Tax and Rs.20,000/- against infra bond, Rs. 5,00,000/- deposited in Fix deposited and Rs.70,000/- deposited in PPF account. As such, total deductions/repayment/savings/ investment is Rs.10,98,720/-. Thus, a sum of Rs.02,96,723/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2010-11.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.37,432/- against balance of previous year.

other allowances is Rs.17,78,563/- and from this amount, Rs.1,06,283/- is deducted against GPF, Rs.3400/- against GIS, Rs.40,541/- against LIC, Rs.1,57,331/- against Income Tax and Rs.20,000/- against infra bond, and Rs.50,000/- deposited in PPF account. Rs. 10,00,000/- paid to DLF Indila limited for registration rregarding purchase of plot in DLF garden city Raibarelly road, Lucknow. As such, total deductions/repayment/savings/investment is Rs.13,77,555/-. Thus, a sum of Rs.04,01,008/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2011-12.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.1,08,125/- against balance of previous year.

In this connection it is submitted that Sri Pankaj MIsra has already submitted his property statement of the financial year 2005-06 (statement is at flag 'M') which had already been seen by Hon'ble Ms. Justice Ran Vijai Singh the then Administrative Judge, Banda at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2006-07 & 2007-08 in

its next financial year i. e. in 2008-09 up to March 2009.
