May kindly see the letter, placed below at flag 'A' received from Sri Pankaj Misra, Chief Judicial Magistrate, Bareilly regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-1 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2012-13, the income from salary and other allowances is Rs.12,33,568/-, Rs. 8,614/- received from other allowances, Rs.18,00,000/- received as house loan from SBI, Mohanlalganj, Lucknow Rs.3,19,002/- received from the maturity of different FDRs, thus the total income is Rs.33,61,184/- and from this amount, Rs.1,38,128/- is deducted against GPF, Rs.4800/- against GIS, Rs.50,541/- against LIC, Rs.83,730/- against Income Tax and Rs.2,20,000/- against house loan, and Rs. 23,25,051/- paid to DLF India limited purchase of plot in DLF garden city Rae Bareli road, Lucknow. As such, total deductions/ repayment/ savings/ investment is Rs.28,22,750/-. The balance of saving bank account (s) of Sri Pankaj Misra is reduced to Rs.4,08,279/- against balance of previous year. Thus, a sum of Rs.09,46,713/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2012-13.
- (2) In the financial year 2013-14, the income from salary and other allowances is Rs.11,24,939/- and Rs.67,070/- received from other allowances, thus the total income is Rs.11,92,009/- and from this amount, Rs.1,49,305/- is deducted against GPF, Rs.4800/- against GIS, Rs.40,541/- against LIC and Rs.97,092/- against Income Tax and Rs.2,94,000/- against house loan. As such, total deductions/ repayment/ savings/ investment is Rs.05,85,738/-. The balance of saving bank account

(s) of Sri Pankaj Misra is reduced to Rs.2,19,828/- against balance of previous year. Thus, a sum of Rs.08,26,099/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial years 2013-14.

In this connection it is submitted that Sri Pankaj Misra has already submitted his property statement of the financial year 2011-12 (statement is at flag 'M') which had already been seen by Hon'ble Ms. Justice Bharati Sapru, the then Administrative Judge, Kanpur Dehat Judgeship at flag 'Z'

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through letter dated 18-03-2015 and as such, there is no delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letter dated 18-03-15 (flagged 'A') of Sri Pankaj Misra, Chief Judicial Magistrate, Bareilly be laid before Hon'ble Mr. Justice Krishna Murari, Administrative Judge, Bareilly Judgeship for Her Lordship's kind perusal and orders?
