

Sri May kindly see the letter/application of Sri Pankey Misra, Addl Chief Judicial Magistrate (Rly), Banda alongwith attested copies of marksheet of LL.M I & II year and copy of degree of LL.M, duly forwarded by the District Judge, Banda regarding inclusion of degree of LL.M in the service records filed below at page 'A'

It may be recalled that Sri Pankey Misra had earlier sent an application dated 27.1.09, <sup>(Marked 'B')</sup> for inclusion of qualification of LL.M (Post Graduate in Law) in the service records but he did not submit photocopy of degree of LL.M to this court.
