It may be recalled that Sni Pankaj Misra had earlier sent an application dated 27.1.09 (Page B) for inclusion of qualification of LL.M (Post Graduate in Law) in the service records but he did not submit photocopy of degree of LL.M to this court

On his application dated 27.1.09 of Sni Pankaj Misra, a court's letter NO 10860/IV-2930/Admin A dated 01-9-2009 (Page C) was sent to the District Judge, Banda with the request to ask Sni Pankaj Misra, Addl Chief Judicial Magistrate Banda to send attested copies of marksheet of LL.M I & II years and attested copy of degree of LL.M, to this court for necessary action

In compliance of court's letter NO 10860/IV-2930/Admin A dated 01-9-2009, Sni Pankaj Misra had submitted attested copies of marksheet of LL.M Ist & II years and degree of LL.M through his letter at May. but date of attestation and full signature of Attesting officer is not mentioned on the marksheets and degree of Sni Misra. Therefore photocopy of marksheet and degree of LL.M of Sni Misra were returned to the District Judge, Banda through court's letter NO. 288/IV-2930/Admin A

dated 11-01-2010 with request to ask Sri Pankaj Mishra to resubmit the copy of marksheet and copy of degree of LL.M duly proper attestation to this court for necessary action

Report-94 / Now Sri Mishra has submitted attested copy of marksheet of LL.M 1st year & 2nd year and degree of LL.M after proper attestation. Attested copy of degree of LL.M and attested copies of marksheets of LL.M 1st & 2nd year submitted by Sri Mishra are at pt of X, Y and Z.

In this connection it is submitted that appointing authority of judicial officers of U.P Nyayik sewa is Government of U.P Lucknow and Sri Pankaj Mishra has got appointment in U.P. Nyayik sewa on 23-5-2001.

Therefore it seems proper that a copy of application dated 27-01-09 of Sri Pankaj Mishra, Addl Chief Judicial Magistrate, Banda regarding inclusion of qualification of LL.M in his service records may be sent to the Government of U.P. as the appointing authority of judicial officers is Government of U.P.
