

May kindly see the letter, placed below at flag 'A', received from Sri Pankaj Misra, Addl. Chief Judicial Magistrate (Rly.), Banda regarding grant of permission to-purchase immovable property i.e. a residential plot at Lucknow.

In his letter, Sri Misra has stated that he wishes to purchase a residential plot no. 11/16, Vrindavan Yozna, Phase-2, Raebareli Road, Lucknow measuring 300 sq. meters from one Smt. Poonam Goyal, W/o Sri Ram Mohan Agarwal, R/o 2nd Floor, Chandra Supreme Complex, Sector-12, Indra Nagar, Lucknow for Rs. 16,80,000/-. He has, therefore, requested the Court to grant him permission to purchase the plot.

		Note: The officer has shown most of the F.D.R.s in his property statement, 2005-06 (flag 'X'), purchased till that year. He has also submitted copies of all the F.D.R.s either purcahsed before joining the judicial service & thereafter, pass books of savings bank & PPF Accounts etc. (flagged 'B', 'B-1' & 'B-2') alongwith his application.

Kerunt-91 It is submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956: -

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority.'

Therefore, if approved by Hon'ble Mr. Justice M. I. Murtaza, Sri Pankaj Misra, Addl. Chief Judicial Magistrate (Rly.), Banda may be granted permission to purchase residential plot no. 11/16, Vrindavan Yozna, Phase-2 of U.P. Awas & Vikas Parishad, Raebareli Road, Lucknow measuring 300 sq. meters from Smt. Poonam Goyal, W/o Sri Ram Mohan Agarwal, R/o 2nd Floor, Chandra Supreme Complex, Sector-12, Indra Nagar, Lucknow for Rs. 16,80,000/-, as requested, subject to the condition that the relevant papers of the transaction alongwith a copy of the sale deed may be furnished by him immediately on completion of the transaction?
