

**RECRUITMENT TO THE POST OF JOINT REGISTRAR

Rachna Arora, Civil Judge (S.D.) of your office has been selected by the competent authority for appointment to the post of Joint Registrar purely on adhoc deputation basis in Armed Forces Tribunal, Regional Bench Lucknow for a period of one year in the pay scale of Rs 15600-39100 (PB-3 Grade Pay-7600) with effect from the date of assumption of charge.
2. The appointment on deputation will be governed by DOP&T OM No 2/29/91-Estt(Pay II) dated 05 Jan 94 and No 2/22(B)/2008-Estt(Pay-II) dated 3rd September 2008 as amended.
3. As per the latest guidelines issued by Deptt of Personnel & Training vide O.M. No AB. 14017/30/2000-Estt(RR) dated 29 Nov 2006, written consent of the officer concerned shall be taken to the terms and conditions of deputation. Accordingly, you are requested to please obtain the written consent on the enclosed undertaking proforma and forward the same to this office at the earliest.
4. The officer will be repatriated to his/her parent cadre without giving any prior notice, in case the performance of the individual is not found satisfactory or for any other reason, since the deputation is purely on adhoc basis.
5. I am also directed to request you to please relieve Smt. Rachna Arora, Civil Judge (S. D.) of your office at the earliest preferably by 15th Dec 2010 and direct her to report to Registrar, Armed Forces Tribunal, Regional Bench Lucknow to take up this appointment on deputation basis.
