May kindly see the letter, placed below at flag 'Z', received from Sri Jaitendra Kumar, Judicial Magistrate, Hapur, Ghaziabad, <sup>duly forwarded by the D.J.</sup> regarding retention of the official residence at Ghaziabad and for grant of permission to attend the Court daily at Hapur from Ghaziabad i.e. to leave the station on every working day.

In his letter, Sri Jaitendra Kumar has stated that he had been transferred to Ghaziabad as Judicial Magistrate from Hamirpur earlier and he had joined at Ghaziabad on 09.06.2004. But thereafter, as per Hon'ble Court's order dated 02.12.2004, he was transferred to outlying Court Hapur, Ghaziabad and accordingly he has joined there on 06.12.2004. He has further stated that at present, he has residing in official residence no.J-90, Govindpuram, Ghaziabad. His daughter is studying in Dehradun Public School, Govindpuram, Ghaziabad, and <sup>he</sup> has small children. He has, therefore, requested the Court to accord him permission to retain the official residence at Ghaziabad due to the circumstances, mentioned above, and also to grant him permission to attend the Court at Hapur every day after performing journey up & down from district Headquarter Ghaziabad.

In this connection, it is submitted that earlier, the matter was dealt with by the Admin (Budget) section and the Learned Registrar (Budget) had submitted a note dated 24.06.2005 (copy is at flag 'Y') in this regard before the Learned Registrar General and the Learned Registrar General has been pleased to direct that 'the matter regarding performing journey up & down i.e. to leave station on every working day is completely separate matter, which is required to be deal with first'. It is further submitted that such type of specific request to attend the Court after performing journey every day from elsewhere is dealt with in Admin(A-4) section, but the matter regarding retention of official residence is dealt with in Admin (Budget) section. In the instant case, the officer is requesting to attend the outlying Court at Hapur every day after performing journey from Headquarter Ghaziabad i.e. to leave the place of posting

on every working day, and acceptance of his request is on the discretion of the Hon'ble Administrative Judge of the judgeship as per prevailing practice.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Anjani Kumar, Administrative Judge, Ghaziabad for his Lordship's kind perusal and orders ?
