May kindly see the letter dated 14.9.05, at flag 'AA' of Sri. Jaitendra Kumar, J.M., Kapur, Ghaziabad, forwarded to this Court by the District Judge, Ghaziabad through his letter dated 14.9.05 at flag 'BB' in the matter of grant of permission to Sri. Jaitendra Kumar to attend the Court daily at Kapur from Ghaziabad.

In this connection, it is submitted that earlier Sri. Jaitendra Kumar vide his letter at flag 'Z' had requested the Court for grant of permission to attend the Court daily at Kapur from Ghaziabad and the matter was put up before Hon'ble the Administrative Judge, Ghaziabad through an office note dated 22.7.05 (flag 'P'). Hon'ble the Administrative Judge, Ghaziabad has been pleased to pass an order dated 6.9.05 (flag 'Q') to obtain certain informations in the matter through the District Judge, Ghaziabad by fax within a week. The required information was asked from the District Judge, Ghaziabad after collecting the same from the officer, vide Court's letter no. 11926 / IV - 2944 / Admin (A) dated 7.9.05. According to the time given, the District Judge, Ghaziabad through his letter dated 13.9.05 (flag 'O') had informed that the Court's letter dated 7.9.05 was sent to the officer on 7.9.05 by post, but the officer has submitted no information, as desired. It was informed that the officer is on leave

from 12.9.05 and as soon as he comes back from leave and submits the desired information, it shall be transmitted to the Court. The report of the District Judge, Ghazabad was, therefore, submitted before Hon'ble the Administrative Judge, Ghazabad through an office note dated 14.9.05 (flag 'cc') and his Lordship has been pleased to order to 'wait till the officer is on leave and submits the desired information'.

Now, in reply of Court's letter dated 7.9.05, Sri. Jaitendra Kumar has submitted the required information vide his letter at flag 'AA', which are as under -

1. The minimum distance of from his residence no. J-90, Sonind Puram, Ghazabad to outlying Court at Hapur is 32 kms.
2. mode of travel is a bus.
3. travel time is about 35-40 minutes.
4. his child is studying in K.G. class.
