May kindly see the letter placed below at flag 'A', received from Sri Mohd. Rizwan Ahmad, Civil Judge (Jr. Div.), Pilibhit regarding grant of permission to get transferred the Fiat Palio Car, bearing registration no. UP25/L-0786 in his own name from his wife's name.

In his letter, Sri. Mohd. Rizwan Ahmad has stated that one Fiat Palio car, bearing registration No. UP25/L-0786 was gifted by his father-in-law to his wife Smt. Akhtar Hina at the time of her marriage on 30.12.2001 and from that day, he alongwith his family are using the vehicle for performance of day to day need and also in his official duties. He has also mentioned the car in his Property statement-2002 and onwards. Now, he wants to get the car transferred in his own name from the name of his wife, for which his wife has no objection. His wife has also written a consent letter in this regard, which is at flag 'B'. He has, therefore, requested the Court to grant him permission to get transferred the Fiat Palio Car bearing registration no. UP25/L-0786 in his own name from his wife's name.

In this connection it is submitted that in the instant case, the applicable Rule-24 (2) of U.P. Government Servant's conduct (Amendment) Rules, 1996 is as follows:-

*"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;*

*Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

It is further submitted that the officer has shown the car in his Property statement- 2002 as well as 2005-06 (flag 'C'). Thus, as per the abovementioned rule and facts, the permission, as requested, may be granted to the officer.

A / Therefore, if approved by Hon'ble Mr. Justice V.M. Sahai, Sri Mohd. Rizwan Ahmad, Civil Judge (Jr. Div.), Pilibhit may be accorded permission to get transferred the
