May kindly see the letters, placed below at flags 'A' & 'A-1', received from Sri Mohd. Rizwan Ahmad, Chief Judicial Magistrate, Allahabad regarding issuance of 'Identity Certificate' for obtaining Passport.

In his letters, Sri Ahmad has stated that there may be a possibility for him to visit abroad in future due to some need and, therefore he wants to obtain passport for himself for which 'Identity Certificate' is required from the Hon'ble Court as per passport rules. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Smt. Jannatun Nisha (Mother), Smt. Akhtar Hina (Wife), Km. Atika Fatima, Km. Juveria Fatima & Km. Aisha Fatima (Daughters). He has, therefore, requested to place his application before the Hon'ble Court for issuance of 'Identity Certificate' for obtaining passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/93-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Ahmad. His request is considerable, as he has submitted required details and papers in this connection.

'A' Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Allahabad Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Mohd. Rizwan Ahmad, Chief Judicial Magistrate, Allahabad as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
