May kindly see the letter, placed below at flag '1', received from Sri Mohd. Rizwan Ahmad, Additional Civil Judge (Senior Division), Meerut by which he has submitted supplementary details/ papers in connection with information about purchase of a new Maruti Swift Dzire car in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of a new Maruti Swift Dzire car for Rs. 6,00,099/- in total through his letters dated 21.05.2012 and 16.07.2012 (flags 'A' & 'A-1'). The matter was submitted before Hon'ble Mr. Justice Sanjay Misra, vide office note dated 07.08.2012 (flagged '2'). In the forwarding note dated 16.08.2012 (flag '3') of Ld. Registrar (B), His Lordship had been pleased to order that:

"The officer has attached copy of bank passbook, but the entry of the same between 24.06.2011 to 07.07.2011 is illegible.

He may be required to furnish legible attested copy of the bank passbook of the aforesaid period."

The order was communicated vide Court's letter dated 14.09.2012 (flag '4').

In reply of the Court's letter dated 14.09.2012 (flag '4'), Sri Mohd. Rizwan Ahmad, vide his letter dated 20.10.2012 at flag '5', has submitted legible statement of account of the period 24.06.2011 to 07.07.2011 of his S.B. A/c no. 25000100285552.

Again a Court's letter has been sent dtd. 04.12.2012 (flag '6'), asking to disclose the source of money of Rs. 5,15,069/- deposited in his S.B. A/c no. 251200010028552 P.N.B., Meerut on 04.07.2011.

In reply of the above mentioned letter dtd. 04.12.2012 (flag '6'), the officer has stated Rs. 5,15,069/- has been received by him through arrears of Sixth Pay Commission in the form of Treasury cheque no. 049237 on 20.06.2011 which has been deposited by him in his said S.B. A/c on 01.07.2011. (Copy of Treasury cheque & ^{deposit slip} ~~passbook~~ are at flags '7' & '8') respectively.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal & further order in the matter of information about purchase of a new Maruti Swift Dzire car by the officer now?
