- 1- I was a practicing lawyer in the Hon'ble High Court of judicature at Allahabad and I had applied for direct recruitment in U.P. Higher Judicial Service Recruitment 2000.
- 2- That prior to it, I had appeared in the U.P.P.C.S. (J) Examination 1999 and after being selected, I have joined as Civil Judge (J.D.) on 25<sup>th</sup> May 2001.
- 3- That the result of U.P. Higher Judicial Service Examination was declared after a long span of about 3 years i.e. in the month of December, 2003 and I had been called for interview.
- 4- That I had moved an application to the Hon'ble High Court vide endorsement no. 1023/I dated 17.12.2003 of the office of District Judge, Siddharthnagar for granting permission to appear in the interview of U.P. Higher Judicial Service Recruitment 2000 and after considering my application, the Hon'ble High Court was pleased to grant permission to me for appearing in the said interview vide Hon'ble Court's letter no. 43/IV-2956/Admn. (A) Dated January, 5,2004.
- 5- That thereafter I appeared on 8<sup>th</sup> January, 2004 for interview, the date already fixed, but, my interview was not taken on that day and I was directed to appear for interview on 17<sup>th</sup> January,2004 vide Hon'ble Court's letter no. 285/2004 dated 08.01.2004.
- 6- That in compliance with the order of the Hon'ble High Court I reached in the Hon'ble High Court of Judicature at Allahabad on 17<sup>th</sup> January, 2004 at 9 a.m. and marked my presence at attendance sheet at serial no. 11 and waited for my turn for being


