May kindly see the representation of Sri Narendra Kumar Singh, Judicial Magistrate, Siddharthnagar forwarded by District Judge, Siddharthnagar vide his endt. No. 54/I dated 22-01-2004 placed below at flag "A" regarding granting permission to appear for interview of U.P. H.J.S. Recruitment-2000.

Sri Singh has mentioned in his representation that he was a practicing lawyer in the Hon'ble High Court of Judicature at Allahabad and he had applied for direct recruitment in U. P. Higher Judicial Service Recruitment-2000. That prior to it, he had appeared in the U.P., P.C.S.(J) Examination 1999 and after being selected, he has joined as Civil Judge (J.D.) on 25th May 2001. That the result of U.P. Higher Judicial Service Examination was declared after a long span of about 3 years i.e. in the month of December, 2003 and he had been called for interview.

He has also mentioned in his representation that he had moved an application to the Hon'ble High Court vide endorsement no. 1023/I dated 17-12-2003 of the office of District Judge, Siddharthnagar for granting permission to appear in the interview of U. P. Higher Judicial Service Recruitment-2000 and after considering his application, the Hon'ble High Court was pleased to grant permission to him for appearing in the said interview vide Hon'ble Court's letter no. 43/IV-2956/Admin.(A) dated January 5, 2004.

He has further mentioned in his representation that he appeared on 8th January, 2004 for interview, the date already fixed, but his interview was not taken on that day and he was directed to appear for interview on 17th January, 2004 vide Hon'ble Court's letter no. 285/2004 dated 08-01-2004 and that in compliance with the order of the Hon'ble High court he reached in the Hon'ble High Court of Judicature at Allahabad on 17th January, 2004 at 9.00 a.m. and marked his presence at attendance sheet at serial no. 11 and waited for his turn for being called for interview but he was not called for interview. That on 17th January, 2004 at about 3.00 p.m., the Registrar (Budget) informed him orally that the Hon'ble Recruitment Committee has declined to take the interview.

In this connection it is submitted that as per Higher Judicial Service Rules 1953 Recruitment for H.J.S as given in Part III-Recruitment is appended below:

- 5. Sources of recruitment:- (1) Recruitment to the service shall be made to the post of Civil and Sessions Judges-
 - (i) by promotion from the members of the Uttar Pradesh Civil Service (Judicial Branch);
 - (ii) by direct recruitment after consultation with the Court.

- (2) Persons eligible for direct recruitment under subclause (ii) of clause (1) of this rule shall be-
 - (a) Barrister, Advocates, Vakils or Pleaders of more than 7 years' standing:

It is pertinent to mention here that at the time of interview Sri S. K. Singh was not Barrister, Advocates, Vakils or Pleaders but at the time of submission of application form and written examination he was not in service.

He has also prayed in his representation that his representation may kindly be placed before the Hon'ble Court for sympathetic consideration and he may be given an opportunity to appear before the Hon'ble Higher Judicial Service Recruitment Committee prior to declaration of final result of U.P. Higher Judicial Service Examination-2000.

If approved the file may kindly be laid before Hon'ble H. J. S. Recruitment Committee for their Lordship's kind perusal and suitable orders?
