May kindly see the letters dated 14.8.16 and 6.2.17 (flagged 'A' and 'A-1') by which Sri Narendra Kumar Singh, Additional District and Sessions Judge, Aligarh has submitted his movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

- In the financial year 2014-15, Sri Singh's income from Salary and (1) other Sources is Rs.12,07,972 from this amount Rs.1,34,079/- deducted against GPF, Rs.4800/- against GIS, Rs.1,33,500/- against Income Tax, Rs.1,38,000/- against PPF, Rs.1,16,819/- against Insurances.. The balance of his Saving Bank Account(s) enhanced for Rs.4,61,454/- this year from deductions/ last balance. As such, total year's repayment/Savings/investment is Rs.9,88,652/-. Thus a sum of Rs.2,19,320/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2014-15.
- (2) In the financial year 2015-16, Sri Singh's income from Salary and other Sources is Rs.14,62,841/- from this amount Rs.1,34,080/-deducted against GPF, Rs.4800/- against GIS, Rs.2,31,030/- against Income Tax, Rs.1,12,996/- against PPF, Rs.1,16,819/- against Insurances. The balance of his Saving Bank Account(s) enhanced for Rs.5,15,676/-this year from last year's balance. As such, total deductions/ repayment/Savings/investment is Rs.11,15,401/-. Thus a sum of Rs.3,47,440/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 14.8.16 (flagged 'A') which was due to be submitted in third financial years 2016-17. As such there is no delay in submitting the Property statement from the part of officer.
