May kindly see the letter dated 30.10.2018 (flagged 'A') by which Sri Narendra Kumar Singh, Additional District and Sessions Judge/Special Judge, Special Court, prevention of Corruption, Gorakhpur has submitted his movable and immovable property statement for the financial years 2016-17 and 2017-18.

(X) In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2016-17, Sri Singh's income from Salary and other Sources is Rs.16,21,781/- (Rs.15,21,047/- from Salary and Rs.1,00,734/- from Bank interest) from this amount Rs.2,02,375/- deducted against GPF, Rs.4800/- against GIS, Rs.2,49,277/- against Income Tax, Rs.1,50,000/- against PPF, Rs.67,485/- against Insurances.. The balance of his Saving Bank Account(s) enhanced for Rs.3,75,824/- this year from last year's balance. As such, total deductions/. repayment/Savings/ investment is Rs.10,49,761/-. Thus a sum of Rs.5,72,020/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2016-17.

(2) In the financial year 2017-18, Sri Singh's income from Salary and other Sources is Rs.16,68,527/- (Rs.15,66,295/- from Salary and Rs.1,02,232/- from Bank interest) from this amount Rs.2,02,375/- deducted against GPF, Rs.4800/- against GIS, Rs.2,51,215/- against Income Tax, Rs.80,000/- against PPF, Rs.67,485/- against Insurances. As such, total deductions/ repayment/Savings/ investment is Rs.6,05,875/-. The balance of his Saving Bank Account(s) decreased for Rs.6,12,681/- this year from last year's balance. Thus a sum of Rs.16,75,333/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2017-18.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 30.10.2018 (flagged 'A') which was due to be submitted in third financial years 2018-19. As such there is no delay in submitting the Property statement from the part of officer.

In this connection it is submitted last time Sri Singh had already submitted his property statement upto financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative
