May kindly see the letter dated 23.09.2013, placed below at flag 'A', received from Sri Vijay Kumar Azad, Civil Judge (Senior Division), Hardoi by which he has requested the Court for issuance of 'Identity Certificate' for obtaining Passport.

In his letter, Sri Azad has stated that he had applied for 'No Objection Certificate' for obtaining passport when he was posted as Chief Judicial Magistrate in District Ghazipur favouring which he had received the same in the month of April 2012 with issuance date of 07.04.2012. In the next fortnight of the same month a notification regarding his transfer to District Hardoi was received due to which the 'No Objection Certificate' was got misplaced and hence it was never used for obtaining the passport. As this 'No Objection Certificate' is valid for six months only from the date of issue as per the Annexure-M of Passport Application form, he needs the renewed copy of 'No Objection Certificate' once again. But now, the Passport issuing authority is asking for 'Identity Certificate' as required document in place of 'No Objection Certificate', for issuance of passport. So it is, therefore, requested to issue him the 'Identity Certificate' as soon as possible. Therefore, by returning 'No Objection Certificate' dated 07.04.2012 in original and by submitting required 'Affidavit' as per section 6 (2) of Passport Act (flag 'B'), other related details and photographs, he has requested for issuance of 'Identity Certificate' for obtaining Passport.

In this connection, it is submitted that from available records, it is evident that Sri Azad was issued 'No Objection Certificate' dated 07.04.2012 (office copy at flag 'C') in the year 2012 on his request, as per approval of Hon'ble Administrative Judge, Ghazipur (order is at flag 'X'). Now, he has submitted that the same certificate was got misplaced and hence it was never used. Thus, he needs 'Identity Certificate'.

It is further submitted that in such type of cases, 'Identity Certificate' may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'D'). Presently as per reports, placed below, no vigilance/departmental enquiry is pending against Sri Azad. As he could not applied for the passport that time on the basis of earlier issued 'No Objection Certificate' dated 07.04.2012 and now, requested for 'Identity Certificate', his request may be considered as per discretion of the Court.
