May kindly see the letter dated 4.7.2015 (at flag 'A') of Sri Vijai Kumar Azad, Civil Judge(Sr.Div.),Sultanpur by which he has submitted his Statements of movable property for the Calendar years ²⁰⁰¹2002, 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11 and 2011-12.

Earlier Sri Azad has submitted his property statements for the Calendar year 2004-05 vide his letter dated 16.2.05(flag 'B') but he has not submitted his property statement for at the time of entering into Judicial Service, hence a Court's letter dated 6.4.05(flag 'C') has been sent to the officer in this regard. But officer has submitted his property statements for the Calendar year 2001-02 vide his letter dated 16.7.2005(flag 'D'). Thereafter a Court's letter dated 17.9.05(flag 'E') has been sent to the officer to send his property statements for the Calendar years 2001, 2002 and 2003 separately to the Court. Again officer has submitted his property statements for the Calendar year 2001-02 and 2004-05 vide his letter dated 3.9.05(flag 'F'). Then a Court's letter dated 10.11.05(flag 'G') send to the officer and another letter dated 20.4.06('H') has been sent to the District Judge, Jalaun at orai with the request kindly to ask the all the Judicial officer posted in his Judgeship to send the require property statement to the Court. In the meantime officer has submitted his property statement for the financial years 2006-08 vide his letter dated 31.7.08(flag 'J') then a Court's letter dated 4.10.08(flag 'K') has been sent to the officer to send the property statement of at the time of entering into Judicial Service. But officer has submitted his property statement for the financial years 2012-13 and 2013-14 vide his letter dated 1.12.2014(flag 'L'). Again Court's letters dated 17.1.15 and 20.5.15(flag 'M' and 'N') has been sent to the officer to submit his required property statement to the Court's at the earliest so that necessary action may be taken in the matter.

Now, the Officer has submitted required property statements for the Calendar years 2001, 2002, 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12 vide his letter dated 4.7.15(flag 'A'), as required in the manner of Court's circular letters.

In this connection, it is submitted that as per the movable and immovable property for the Calendar years 2001, 2002, 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the Calendar year 2001 (from 30.6.2001 to 31.12.2001), Sri Azad's total Income from Salary is Rs.96,800/- from this amount, he has paid Rs.540/- against GIS, Rs.1,000/- against PPF. As such, total deductions /Savings/investment is Rs.1540/-. Thus a sum of Rs.95,260/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the Calendar year 2001.

(2) In the statement of movable and immovable property for the Calendar year 2002, Sri Azad's total Income from Salary is Rs.1,50,078/- from this amount, he has paid Rs.720/- against GIS, Rs.9898/- against LIC. And Rs.1,000/- against PPF. As such, total deductions /Savings/investment is Rs.11,618/-. Thus a sum of Rs.1,38,460/- was therefore available with him to meet out the household

expenditure of his family consisting of two members in the Calendar year 2002.

(3) In the statement of movable and immovable property for the Calendar year 2003, Sri Azad's total Income from Salary is Rs.1,25,523/- from this amount, he has paid Rs.600/- against GIS, Rs.10,000/- against Income Tax, Rs.1,000/- against PPF and Rs.19,901/- against LIC policy. As such, total deductions /Savings/investment is Rs.31,501/-. Thus a sum of Rs.94,022/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the Calendar year 2003.

(4) In the statement of movable and immovable property for the financial year 2004-05, Sri Azad's total Income from Salary is Rs.3,41,448/- from this amount, he has paid Rs.1,14,915/- against GPF, Rs.720/- against GIS, Rs.11,444/- against Income Tax, Rs. Rs.25,000/- against PP, Rs.19,901/- against LIC. The balance of his Saving Bank Account(s) has enhanced around Rs.50,000/- this financial year. As such, total deductions /Savings/investment is Rs.2,21,980/-. Thus a sum of Rs.1,19,468/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the Calendar year 2004-05.

(5) In the statement of movable and immovable property for the financial year 2005-06, Sri Azad's total Income from Salary is Rs.1,82,677/- from this amount, he has paid Rs.55,172/- against GPF, Rs.720/- against GIS, Rs.2806/- against Income Tax, Rs.5,000/- against PPF, Rs.32,072/- against LIC. As such, total deductions/Savings/investment is Rs.95,770/-. [The balance of his Saving Bank Account(s) has decreased for Rs.47,322/- this financial year.] Thus a sum of Rs.1,34,229/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2005-06.

(6) In the statement of movable and immovable property for the financial year 2006-07, Sri Azad's total Income from Salary is Rs.2,65,225/- from this amount, he has paid Rs.39,000/- against GPF, Rs.1440/- against GIS, Rs.6428/- against Income Tax, Rs.15,000/- against PPF, Rs.49,600/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.1,17,492/- this financial year. As such, total deductions /Savings/investment is Rs.2,28,960/-. Thus a sum of Rs.36,445/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2006-07.

(7) In the statement of movable and immovable property for the financial year 2007-08, Sri Azad's total Income from Salary is Rs.4,29,668/- from this amount, he has paid Rs.36,000/- against GPF, Rs.1440/- against GIS, Rs.22,913/- against Income Tax, Rs.15,000/- against PPF, Rs.50,000/- against FDR, Rs.49,600/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.1,77,755/- this financial year. As such, total deductions /Savings/investment is Rs.3,52,708/-. Thus a sum of Rs.76,960/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2007-08.

(8) In the statement of movable and immovable property for the financial year 2008-09, Sri Azad's total Income from Salary and other sources is Rs.5,12,990/- from this amount, he has paid Rs.94,190/- against GPF, Rs.1440/- against GIS, Rs.14,347/- against Income Tax, Rs.50,000/- against FDR, Rs.70,000/- against PPF, Rs.1,49,600/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.64,446/- this financial year. As such, total deductions /Savings/investment is

Rs.4,44,023/-. Thus a sum of Rs.68,967/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2008-09.

(9) In the statement of movable and immovable property for the financial year 2009-10, Sri Azad's total Income from Salary and others Sources is Rs.4,52,714/- from this amount, he has paid Rs.75,935/- against GPF, Rs.1440/- against GIS, Rs.23,039/- against Income Tax, Rs.70,000/- against PPF, Rs.99,600/- against LIC. [The balance of his Saving Bank Account(s) has decreased for Rs.39,842/- this financial year.] As such, total deductions /Savings/investment is Rs.2,70,014/-. Thus a sum of Rs.2,22,542/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2009-10.

(10) In the statement of movable and immovable property for the financial year 2010-11, Sri Azad's total Income from Salary and other Sources is Rs.7,50,859/- from this amount, he has paid Rs.60,000/- against GPF, Rs.1440/- against GIS, Rs.59,456/- against Income Tax, Rs.18,000/- against R.D., Rs.70,000/- against PPF, Rs.99,600/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.42,922/- this financial year. As such, total deductions /Savings/investment is Rs.3,51,418/-. Thus a sum of Rs.3,99,441/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.

(11) In the statement of movable and immovable property for the financial year 2011-12, Sri Azad's total Income from Salary and other Sources is Rs.17,02,172/- from this amount, he has paid Rs.1,42,505/- against GPF, Rs.2840/- against GIS, Rs.3,11,141/- against Income Tax, Rs.24,000/- against R.D., Rs.50,000/- against NSC, Rs.70,000/- against PPF, Rs.99,600/- against LIC. As such, total deductions /Savings/investment is Rs.7,00,086/-. The balance of his Saving Bank Account(s) has decreased for Rs.40,744/- this financial year. Thus a sum of Rs.10,42,830/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.

(12) In the statement of movable and immovable property for the financial year 2012-13, Sri Azad's total Income from Salary and other Sources is Rs.11,72,645/- from this amount, he has paid Rs.86,755/- against GPF, Rs.4400/- against GIS, Rs.1,00,343/- against Income Tax, Rs.99,500/- against LIC and Rs.60,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,50,998/-. The balance of his Saving Bank Account(s) has decreased for Rs.1,25,632/- this financial year. Thus a sum of Rs.9,47,279/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(13) In the statement of movable and immovable property for the financial year 2013-14, Sri Azad's total Income from Salary and other Sources is Rs.12,59,831/- from this amount, he has paid Rs.1,42,494/- against GPF, Rs.4800/- against GIS, Rs.1,55,670/- against Income Tax, Rs.60,000/- against PPF, Rs.99,500/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.80,876/- this financial year. As such, total deductions /Savings/investment is Rs.5,43,340/-. Thus a sum of Rs.7,16,491/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

It is also to mention that the officer has also declared income of his wife @ Rs. 40,000/- per year till February 2009 from the shop of desi wine at Agra allotted in her name before marriage, run by her own employees.

The movable and immovable property statement for the Calendar years 2001, 2002, 2003 and financial years 2005-06, 2008-09, 2009-10, 2010-11, 2011-12, has been submitted by the officer vide his letter dated 4.7.2015(flag'A'), property statements for the financial year 2004-05 has been submitted by the officer vide his letter dated 19.2.05(flag 'B'), for the financial years 2006-08 vide his letter dated 31.7.08(flag 'J') and for the financial year 2012-13 and 2013-14 vide his letter dated 1.12.14(flag 'L'). The property statements for the Calendar years 2001, 2002, 2003 was due to be submitted in the beginning of next financial year. The property statement for the financial years 2004-05 and 2005-06 was due to be submitted in the financial year 2006-07. The property statement for the financial years 2006-07 and 2007-08 was due to be submitted in the financial year 2008-09. The property statement for the financial years 2008-09 and 2009-10 was due to be submitted in the financial year 2010-11. The property statement for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13. The property statement for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15. As such there is delay in submitting the Property statements for the Calendar years 2001, 2002, 2003 and financial years 2005-06, 2008-09, 2009-10, 2010-11 and 2011-12 from the part of the officer for which officer has regretted.

May, if approved, the statements of movable and immovable property for the Calendar years 2001, 2002, 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Vijai Kumar Azad, Civil Judge(Sr.Div.),Sultanpur may kindly be laid before Hon'ble Ms Justice Naheed Ara Moonis, Administrative Judge, Sultanpur Judgeship for Her Lordship's kind perusal and orders ?
